ASTHS Little Axe Clinic Ground Breaking Ceremony

The Absentee Shawnee Tribal Health System (ASTHS) conducted its ground breaking ceremony, May 20, for Phase I of the two-phased expansion project. Phase I is the expansion of space and services at the Little Axe Clinic, and Phase II is the construction of a new state-of-the-art Shawnee Clinic. This two-phased project, referred to as the Enhanced Health System Project, will increase patient care and services at both main service locations in Shawnee and Norman, adding in new services, equipment, expanded grant programs, and greatly increase patient ease in accessing services for the AST and other Native American community

members in which we service. The event capped off a great week of celebration as the AST Health System celebrated its 10th Anniversary of opening the new Little Axe Clinic, and has already outgrown the clinic in a very short time due to the health care services provided and needs of the community and surrounding areas.

The Executive Committee and the Health Board were all in attendance as Governor Johnson provided the keynote address for the event. "Health programs are a priority to all Tribal Nations to grow, nurture and develop the next generation to care for the current generation. The strength of any Tribe can be measured in

the success and strength of their health programs, which measures the health of the tribe." Johnson said. "This expansion is greatly needed to help service our Tribal Members better and offer additional services."

The AST Veteran's Association posted the colors and many of the AST Elders were present to participate in this historic event as the Tribe enters a new phase in patient care and servicing with the project. Various dignitaries from the community were also in attendance including Rear Admiral Travis Watts, I.H.S. OKC Area Office Director, and Dr. Greg Witte, Chief Medical Officer, also with

the I.H.S. Area Office. Representatives from BancFirst, FSA Investment Group, Childers Architect, Connect Advisors, Manhattan Construction Company, along with other notable attendees were also present as well as numerous other supporters and key partners that made the project happen!

As we all endeavor to continue to improve the health and wellness of all Native American families we serve, today we entered a new phase of growth that will positively impact the surrounding communities and families of the AST Tribe, and all surrounding Tribes, for years to come!

Tribe Creates Workforce Development and Career Initiative Program



Due to the COVID-19 pandemic over the last few years, it has had a detrimental effect on the labor markets. Millions of people were furloughed or lost their jobs while others had to rapidly adjust to working at home. The COVID-19 pandemic and the resulting economic crisis affected the health and economic well-being of the American workforce. These same negative effects of COVID-19 also affected the Absentee Shawnee Tribe of Oklahoma in the same manner.

In 2021, The Executive Committee of the Absentee Shawnee Tribe of Oklahoma made a progressive decision to invest Cares and ARPA funding to our tribal membership. This decision was an effort to get people back to work by empowering our tribal membership to get an education/training for future employment.

Through our research we found that HVAC (Heating, Ventilation & Air Conditioning) is one of the fastest growing fields today. In 2019, there were an estimated 380,000 HVAC jobs in the United States, with a projected growth rate of 4% from 2019 to 2029. In fact, there are more HVAC job openings than there are qualified technicians to fill the jobs. HVAC

salaries in Oklahoma for 2022 show entry pay at \$42,200 and supervisory salaries at \$76,000 and above. The field can be lucrative if one has the right skill set. The Workforce Development and Career Initiative program at the tribe aims to help members get those skills and excel in their career.

The Absentee Shawnee Tribe recently created the Workforce Development and Career Initiative program to help tribal members acquire HVAC jobs. This new program was started with ARPA and CARES funds. Lt. Governor Ezra DeLodge and Representative DeWayne Wilson were instrumental in bringing this program to light.

"We want to create a program that will help our members obtain the skills to find a job in the HVAC field and become successful," said Wilson. "Our hope is they would even find employment here at the tribe or other tribal entities."

This pilot program is designed to hire an HVAC person and invest in tribal members with training and employment. By hiring an HVAC person in this area, this will eliminate some if not most of the HVAC contractual cost the tribe spends

for the next two and half years. It will also allow the tribe to provide apprenticeship and supervision to the tribal members who are seeking a career in the HVAC field. The program will allow a limited number of tribal members to obtain an HVAC Journeyman license by the end of his/her second or third year. The tribe and HVAC qualified tribal member(s) will agree to a one year work agreement after completing their training.

The program isn't just for unemployed. Anyone wanting to learn this skill set can apply. The Absentee Shawnee Tribe has partnered with Moore Norman Technology Center and Gordon Cooper Technology Center and is currently accepting applications. The three-year program consists of one year of classroom training, the second year of work-based learning at the tribal complex and the third year pay-back by working for the Absentee Shawnee Tribe as a paid employee.

Tribal member Thad Breeding graduated from Gordon Cooper Technology Center in HVAC immediately after high school. He has been in the HVAC field for over 2 decades and owns his own company -Tri-County Air Solutions based in

Shawnee.

As a graduate of the program, Breeding highly recommends it to anyone. "Take advantage of all the tools available to you as a student and tribal member to succeed! People needed to fill the construction trade jobs are in high demand right now. These jobs aren't going anywhere; we will always need HVAC, electric, and plumbing."

The requirements for the tribe's program are: Absentee Shawnee Tribal Member (provide proof of tribal membership); complete a Vocational Assessment (must have/obtain a 10th grade math and reading level); complete a Workforce Development and Career Initiative Application; must have a High School diploma/GED (copies accepted); valid driver's license; pass criminal background check; provide essay response; provide letter of recommendation (optional) and must complete Federal Aid (FAFSA) and provide copy with application.

For 2022, we have collected, processed, and recycled 20 bales of shredded office paper and cardboard equaling roughly 15 tons of recyclable waste that has been diverted from landfills. OEH has completed the scheduled electronics recycling collection event. There were two trailers full of computers, monitors, printers, and miscellaneous electronics that were collected for disposal.
Construction on the Youth Camp cabins, and bathhouse have been complete. We are currently awaiting approval of the loop road to complete the entry gate.
We are currently at 95% completion of the design phase for the new Police Safety Center. The Tribe is currently reviewing the drawings and specifications to approve the design. We expect these drawings to be finalized and to begin the advertising for bids for general contractors around the beginning of June.

Self-Governance Department:
I attended the NINATEC Conference in Catoosa, OK from May 2nd through May 5th. During this Conference I learned more about other 477 tribes and how they have grown. 
I attended the Groundbreaking for the Little Axe Health Clinic. Besides taking pictures to commemorate the event, I was also able to visit with members in attendance. I was honored to assist our Eldest Female member, who participated and got to wear a hardhat. As part of the activities, we were allowed to tour the

unfinished Storage Facility. Upon completion, this will provide an additional 15,000 Square Feet of storage space for the Health Systems.

And finally, I want to acknowledge the handful of employees who volunteered to provide assistance after the tornadic event in and near Seminole. Though many may not recall, our community was in a similar circumstance three consecutive years in a row back in 2011, 2012, and 2013. As one who remembered those situations, I'm glad Emergency Management helped coordinate an effort to provide relief. In collaboration with Enrollment, we were able to determine there are 53 AST members who live in those affected areas. We were able to call and check on their safety and help remove debris in Tecumseh, Earlsboro, and Seminole. We are thankful there were no major injuries and/or deaths.

REPRESENTATIVE'S REPORT

Hello Tribal Members,

I hope and wish your families are in good health and enjoying the opportunity to visit others. I want to say that I really enjoyed myself at the South Dance ground (Bread Dance) this month. It was uplifting to me to see so many tribal members participating in this ceremonial event, especially our young people. The good food and good company made for a good time. I also wanted to say "Thank You" to the Blanchard family for inviting me to their family camp and the hospitality I received. My thoughts and prayers continues to go out to the tribal families that have lost love ones.

Education Department;

The Workforce Development Committee consisting of the Lt. Gov., Education Director, Human Resource, and I (Representative) have been real busy. We are having meetings to finalize the Workforce Development application. We continue

having meetings and telephone conversations with Moore/ Norman and Gordon Cooper Technology Centers as they develop their training opportunities in the HVAC profession. Last month, we announced for a HVAC mechanic position. This month, we have interviewed for the HVAC mechanic position. Finally, we are advertising the Workforce Development and Career Initiative (pilot program) on tribal websites and newspaper.

Cultural Preservation Department;

The Cultural Preservation Department is busy. They continue to see increases in activities, visitors, and Gift Shop sales. They have also seen increases in projects in the THPO and FCC/ TCNS programs. As for the ANA/ Language Grant, we really haven't seen an acceptable candidate for the Linguist/ Project Coordinate position. We are discussing the possibilities of contracting for the Linguist position. We will have to get approval from ANA prior to doing so.

Youth Camp;

Again, due to some extenuating cir-

cumstances, there has not been much construction going on at the Youth Camp during this reporting period. Last month it was the Youth Camp Road. This month, it's the construction of the recreational facilities project. I will keep everyone informed of the progress or lack of progress pertaining to this project.

I did attend the 42nd Annual National Indian and Native American Employment and Training Conference in Tulsa, Okla. during May 2- 5, 2022. This was an exploratory mission concerning Public Law 102-477. I attended workshops such as; Determining Programs that Fit your 477 Plan (Tribal Decisions/ Tribal Choice), How to Develop a Blended Plan, Program Review- Today's Process and What is Required, and how other Tribes are Utilizing PL 102-477. I also had conversations with Chief Principal David Hill, Muscogee (Creek) Nation and Principal Chief Chuck Hoskin Jr., Cherokee Nation about getting Native Americans involved in the electoral process and Workforce Development issues that we are all hav-

ing. Both the Muscogee (Creek) Nation and the Cherokee Nation are grantees of Public Law 102-477 as well as supporters. Lt Gov. Ezra Delodge and I met with U.S. Secretary of Labor Mr. Martin J. Walsh as well as other Tribal leaders. Mr. Martin discussed Workforce funding from the federal level. On the last day of the conference, Self-Governance Director Twyla Blanchard and I, met with Mr. Anthony Riley, Acting Associate Deputy Bureau Director and Ms. Ida Doyle, both are with the BIA/ Division of Workforce Development. We discussed other training opportunities and grant funding that P.L. 102- 477 offers as well as the 477 application and reporting requirements.

ELECTION COMMISSION

APPROPRIATE POLL BEHAVIOR

According to the Election Ordinance Article VIII Section 1 – The official polling sites and adjoining Tribal Grounds are neutral grounds, therefore, there shall be no campaigning or loitering on Election Day by any person. It shall be the duty of the Election Commission to request that Tribal police, be present at each polling place and be responsible for maintaining order, prevent campaigning, and loitering during the election process.

In order to comply we suggest that you do not campaign in any fashion.

For Examples:

- No: "vote for. ." sticker on cars;
- campaign clothing;
- disbursement of campaign material;
- counseling as to who to vote for.

Do not loiter at poll site:

1. Arrive;
2. Register;
3. Vote;
4. Exit.

Unless there is a line each voter should be at the poll no more than 10 minutes, outside of voter booth. Each voter may take all the time they need to read the ballot to vote in the private booth but should not "visit" with Commissioners or other voters at the poll site.

Any visiting of voters must occur outside of the Poll Site and adjoining Tribal grounds.

Voting Polls close at 6:00 p.m. Voter has to be in line in order to vote.

Policies and Procedures states:

There shall be no campaigning on property of polling site. This includes signs, person to person, clothing, etc. or within 200 ft. of the polling site. (On Election Day all signs must be over 200 ft. away from the edge of tribal property that contain poll sites).




Tribal member Sam Brown was a finalist in Sodexo's Future Chefs Challenge 2022. He is a 5th grade student at Bethany Public Schools.

Day to day operations have continued to be carried out by each program coordinator to ensure the department as a whole continues to function properly. Following is a breakdown of each departmental program's most recent activities.

Gift Shop

Our Shawnee Gift Shop is located at the complex in the Cultural Preservation building (building 6), and our Little Axe Gift Shop is located in the lobby of the Little Axe Health Center. We are open in Shawnee Monday – Friday 8 a.m. to 5 p.m. and once a month, usually at the end of the month, in Little Axe from 9 a.m. to 3 p.m.



Currently, to make room for new spring inventory, we are having a SALE! The sale includes such items as t-shirts, hoodies, polo shirts, button down blouses/shirts, and shoes (please see the picture to the left). The items are priced to move, so please stop by and have a look!! You may find something you cannot pass on.

We continue to look and reach out to new businesses especially Native American owned businesses and vendors in hopes of bringing in new inventory. Over the past month, we have added a few more vendors, and hopefully, soon we will have some new items available.

If you haven't been in our store recently, please stop by either location. Maybe you can find that special gentleman in your life a Father's Day gift or maybe find something for yourself.

Library

We are happy to announce that we have opened the library to the public! Please come in and visit. We have a wide variety of resources available for checkout, and many magazines, newspapers and journals for your reading leisure. We look forward to serving your informational needs!

THPO

The THPO Program continues to make great strides and advancements. The THPO staff has steadily been receiving Section 106 projects from various Federal Agencies. Over the past month, the THPO Officer, Mrs. Devon Frazier-Smith, has received 304 new Section 106 projects for review. In conjunction with receiving projects, the program has consulted on 249 projects. These projects were completed in 18 of our 25 areas of interest/states. The THPO has also taken part in 15 teleconference calls as it concerns Section 106 projects as well as NAGPRA cases. These calls were with such Federal Agencies as Tennessee Valley Authority, the National Park Service, and the Department of Transportation for Texas and Wisconsin.

From April 19th through the 20th, Mrs. Frazier-Smith attended the 2022 AL/FHWA Annual (Virtual) Consultation. At this consultation, topics covered were new and old projects, upcoming programmatic agreements, trainings, and NAGPRA updates.

FCC/TCNS

The incoming workflow of new and modified telecommunications projects has been steady for the TCNS program. The THPO Specialist, Ms. Ashley Brokeshoulder, has been busy reviewing, researching and given recommendations to the telecommunications industry. Over the past month, she has received 139 new telecommunications facility projects for review. These 139 individual projects will be completed in conjunction with 12 consulting firms in 13 of our 25 areas of interest/states.

In conjunction with receiving projects, she has reviewed, researched and gave recommendation for the clearance of 107 telecommunications projects. These 107 individual projects were completed in conjunction with 12 consulting firms in 13 of our 25 areas of interest/states. Also, 32 projects are awaiting clearance because their packages are lacking some information such as full archaeological reports, SHPO responses, or clear pictures.

EVENTS

On April 8th, Cultural Preservation hosted a yarn belt workshop at the Multipurpose Building in Shawnee. Ten individuals were in attendance. Most of the ten individuals were able to at least get their yarn belts started.

On April 12th, the Library hosted a ribbon skirt workshop at the community building in Little Axe. At this workshop, the basics as well as a few advances techniques were taught. Nine individuals were in attendance. Like with the yarn belt workshop, most of the individuals were able to get their skirts started, and one individual completed their skirt.

May 5th was National Day of Awareness for Missing and Murdered Indigenous Women, Girls, People. To honor and bring awareness to the multitude of Alaska Native and American Indian women, girls, people who have been murdered or gone missing, Cultural Preservation hosted a solidarity walk. The department also displayed red dresses on the porch of the building to symbolize a portion of those who have been murdered or is missing.



Why Are No-Show Appointments a Big Deal Anyway?

We are all so very busy getting on with life in the recovery phase of the pandemic today. With the fast pace of life and taking care of our families, we need to remember and be diligent on the important things we learned and valued during the pandemic – our health, and the health of our families, the tribe, and our communities! Patients who fail to show up to scheduled appointments or cancel at the last minute - giving the AST Health System no opportunity to fill the appointment slot - are often referred to as “no-shows.” A no-show appointment results in loss of time and money for the health system, and disrupts continuity of care for other patients. Patients who schedule clinic appointments, and fail to keep them, have a negative impact on other patients needing care, impacts health system negatively in productivity, and not failing to mention the obvious, leaves a medical professional ready to take care of you running idle.

The financial impact is not relieved by same-day appointments. The size of the problem varies nationally, but industry experts state “no-shows” negatively impact not only financially and from a resource management perspective, but also negatively impact the patient experience and quality of life of the patient by not receiving routine medical screenings, preventative oral health exams and cleanings, as well as the other services which we experience “no-shows” for in the healthcare field today.

The American Medical Association policy says a doctor may charge for a missed appointment - or for failing to cancel 24 hours in advance in the private sector - if the patient is fully advised that such a charge will be made. Otherwise, it comes down to a notice to you, your justification for canceling, and if the doctor's office is serious about enforcing their no-show policy. Fortunately for our patients, we do not, and would not, and cannot, ever entertain charging patients for no-show appointments, as this is not an authorized charge we can charge as an I.H.S. ITU entity; however, it is bad for business and for any tribal health program and although it may seem like a small thing, it actually has a huge cumulative negative impact. If you can help us with this effort, we will commit to helping you, help us, make a better patient experience for you and your healthcare needs!

7 Ways We Try to Reduce Patient No-Shows to Serve You Better:

1. Make reminder calls.
2. Set up automatic reminders.
3. Keep and manage a wait list.
4. Don't wait to reschedule your no-shows.
5. Some patients need extra reminders.
6. Be proactive with your schedule.
7. Have a written policy that is enforced upon repeat offenders.

Men's Health Week

Men's Health Week always begins on the Monday before Father's Day and ends on Father's Day itself. During 2022, it will run from Monday the 13th until Sunday the 19th of June. The week is all about encouraging healthy bodies, hard exercise, good diet, and regular visits to the doctor for check-ups. The overall goals of the week are to heighten awareness of preventable health problems for males of all ages, support men and boys to engage in healthier lifestyle choices/activities, and encourage the early detection and treatment of health difficulties in males.

Healthier men live happier, longer lives. Men should follow up routinely with their primary care physician for check-ups. Cardiovascular health is one of the body systems the doctor will likely look into. It is estimated that 1 in 3 men are affected by heart conditions. Changes in diet and lifestyle, limiting alcohol intake, reducing stress, in addition to exercise, can help lower the risk of developing heart disease reducing the risk of having a heart attack or stroke. The physician will likely order blood work to check cholesterol and a glucose level to assess the risk for heart disease.

Another thing a primary care physician will monitor for is cancer. Prostate cancer is the leading cancer for men in the United States. It is followed by lung cancer and then colorectal cancer. Prostate cancer can be cured typically if it's detected early. Men who are at high risk should begin yearly screening for prostate cancer at age 40 or earlier, all others at age 50. The doctor may choose to draw a PSA blood test or do an exam of the area.

Your physician will likely assess your mental health and well-being at your visit. Depression is under-diagnosed in men. Men are four times more likely than women to commit suicide. As you age, you may also start to feel stressed or depressed to the loss of a loved one, health problems or financial difficulties. Just as the body changes with age, so does the mind. You may find that you're misplacing things or you're just not as on top of things as you used to be. You may experience memory loss and other intellectual abilities serious enough to interfere with daily life caused by dementia. Stress may cause you to lose energy, fail to eat enough or isolate yourself. It's important to communicate any of these changes with a trusted health professional.

Important things to remember: limit the number of alcoholic drinks consumed in a week, stay active, maintain a healthy diet, get at least 7-8 hours of sleep a night, and check in with your family doctor on a consistent basis to stay healthy for as long as possible.



MEDICINE WHEEL & 12 STEPS



The medicine wheel and 12 Step program was developed to provide a culturally appropriate 12 Step program for Native American people. This program was developed by White Bison, based upon teachings of the Medicine Wheel, the Cycle of Life and the Four Laws of Change.

HOW THE PROCESS WORKS

The Medicine Wheel and 12 Step program is designed in a series of modules that enable people to meet their individual needs. Participants watch a video that explains Medicine Wheel teachings and apply them to their lives. In addition, participants share their insights and experiences in a talking circle. They also learn how to mind map their own innate knowledge around these teachings and then apply that knowledge to their daily lives and decision making processes. For those working through the program in a group setting (i.e. Circles of Recovery) very strong social and emotional bonds are created that help the individuals who participate to develop trust, autonomy, and other healthy feelings and thought patterns that will help them to grow emotionally, mentally, physically, and spiritually.

FOCUS

The focus of the program is on character and values. Thus each of the 12 Steps is presented from the perspective of the value that it reflects.

TEACHINGS OF THE MEDICINE WHEEL

The Medicine Wheel is an ancient method for teaching important concepts about truth and life. Many Native American communities use a Medicine Wheel, although the colors and the symbols are different depending upon the culture. The purpose is the same in each culture. These teachings, when applied to one's life, have the power to influence significant change in attitudes, behaviors, values and intent. The Elders have shared a series of Teachings based upon the Natural Order of the way things should be. These are sometimes referred to as the "original instructions." These important Teachings are included in the

4. Must provide Proof of Residency (utility bill – in the applicants name)
5. Handicap/Disabled
6. NO RENTAL PROPERTY WILL BE MOWED

As a Title VI Member as long as you are within the guidelines you can put in your application and turn in your applications to the Title VI Department. As stated on the application: Maintenance will only mow and weed eat applicants lawn. Maintenance will mow every two (2) weeks weather permitting. Also, the maintenance workers will not trim trees, shrubs, and will NOT move any items that are in the way of cutting your lawn.

Help yourself, help your tribe and see if you will qualify for coverage that will provide you and your family with immediate access to specialized healthcare at no cost to you or your tribe.



Did you know? The American Rescue Plan (ARP), recently signed into law by President Biden, increases and expands eligibility for cost-savings programs under the Affordable Care Act (ACA) in the form of premium cost assistance for individuals enrolled in Health Insurance Marketplace plans.

The premium assistance is in the form of a IRS Advance Premium Tax Credit taken in advance of the tax year, lowering or eliminating health insurance premiums for lower- and middle-income families. Signing up for a low-or-zero cost health plan allows tribes to receive reimbursement for services, which frees up more dollars to help those who are not eligible for cost-savings programs, helping Purchased Referred Care dollars go further.

Native Americans must apply for all available resources, if eligible, to help augment the cost of tribal healthcare services. Program rules and continuity of care necessitates completion of an annual application for benefits to assure services are covered, even if ASTHS patient is already insured.

What to Know if You Must Visit an Office:

- You must have an appointment to visit an office.
- Masks are required for all office visitors and employees, regardless of vaccination status.
- Visitor capacity is limited to follow physical distancing requirements. This means you may need to wait outside, so plan for cold or bad weather.
- We ask that you come alone unless you require help with your visit. If you require help, we can only permit one person to accompany you.

Under 65? Apply for SoonerCare Medicaid Expansion

You could be eligible for SoonerCare Medicaid Expansion benefits, which includes full-scope medical and limited comprehensive dental coverage, for adults ages 19-64 if your income falls at or below 138% of the Federal Poverty Level (FPL)—under \$18,768 per year for an individual; under \$38,304 per year for a household of 4 (Children eligible at a higher income threshold under 210% FPL). Per Purchased Referred Care guidelines, all patients under 65 years old, whether insured or uninsured, must apply for SoonerCare to help augment the cost of tribal healthcare services. Help yourself, help your tribe and see if you and your family will qualify for state health insurance benefits at no cost to you or your tribe.

Program rules and continuity of care necessitates completion of an annual application for benefits to assure services are covered, even if ASTHS patient is already insured.
