The Executive Committee wear their masks to protect Absentee Shawnee Tribal Elders, tribal members and AST employees.

Every day, Oklahomans wear masks to protect someone they love.

As the number of coronavirus cases continues to grow in Oklahoma, using masks are still among the best methods to prevent community spread. There are many reasons we should wear masks:

- To protect someone you love: When you wear a mask you protect others by preventing the spread of your own germs.
- Protect the community: More people wearing masks results in better protection for everyone.
- Unknown COVID-19 status: You may have COVID-19 or have been exposed to the virus without showing symptoms.

While some people may touch their face more often when wearing a mask, it's possible to reduce infection risk with good hygiene. Be sure to wash hands frequently, wash your cloth mask after wearing and know how to properly put on and remove your mask. You can learn more by reviewing the CDC's guidance on how to wear cloth face coverings.

Some people have heard that breathing in CO2 from wearing a mask can cause symptoms like dizziness, lightheadedness,

headache, and shortness of breath. However, the amount of CO2 created by wearing a mask is miniscule and most casual mask wearers will not experience anything more than a mild headache. Also, be aware that once a mask gets wet (perhaps from exhalation), it begins to lose its effectiveness and will need to be washed or replaced.

The CDC (Centers for Disease Control and Prevention) recommends widespread use of simple cloth face coverings to help prevent transmission of COVID-19 by people who have the virus but don't know it. But it's not a substitute for physical distancing. Staying at least 6 feet apart from others while in public is still the most important tool to stopping the spread of the virus, according to the CDC.

AST COVID-19 Education Aid Program

In Response to the COVID-19 pandemic and public health emergency, the Executive Committee of the Absentee Shawnee Tribe has established the COVID-19 Education Aid Program. This service will assist tribal member students directly impacted by the changing methods in which educational facilities are highly impacted on how they will deliver education.

The COVID-19 Education Aid Program is intended to provide assistance for tribal member students during the pandemic. Social distance learning is becoming a matter of great importance in keeping our students safe from spreading the virus. Therefore, technology has become a great learning tool for students and teachers safety through COVID -19.

The COVID-19 Education Aid Program will provide gift cards of (\$500.00) for tribal member students between Pre-k through College. The funds will go towards helping our tribal students in response to the COVID-19 pandemic and public health emergency effect on our educational facilities. The gift card must be used for purchasing necessary educational items in regards to virtual learning or school supplies.

Education Aid Program Eligibility:

- Must be an enrolled member of the Absentee Shawnee Tribe of Oklahoma on or before **June 1st, 2020**
- Must be an enrolled student Pre-k through College
- Must complete the COVID-19 Education Aid Program application for the tribal member student.
- Must have a copy of student's class schedule (or documentation stating the member is a student of said school).
- Must have a copy of student's current CDIB card (attached to application).
- All applications **MUST BE SUBMITTED ON OR BEFORE WEDNESDAY, SEPTEMBER 30th, 2020.**
- **FUNDS MUST BE USED BY THURSDAY, DECEMBER 31st, 2020 BEFORE 11:59 P.M.**

If you were unable to make the distribution events, you may email educationaid@astribe.com to schedule a pick-up appointment (after September 1st) or opt to have your card mailed.

**** MANDATORY REQUIREMENT: Once purchases have been made with the gift card, all receipts must be received by AST Finance Department by December 30th, 2020 ****

ADDITIONAL NOTES

- College students applying for the COVID-19 Aid Program must be enrolled in no less than 6 credit hours per semester. Technical school students applying for COVID-19 Aid Program must be enrolled into a program full-time.
- Online learning institutions will need a class schedule of no less than 6 credit hours per semester or a school verification letter with school seal/stamp.
- Homeschool students, applying for the COVID-19 Aid Program will need to provide a copy of a letter from the principal of the school district where the child resides. We also understand some homeschools have parents sign a form which releases them from the responsibility of educating the student, this form would be acceptable for verifying enrollment.

AFTER MAKING PURCHASE(S), A RECEIPT WILL NEED TO BE TURNED IN TO THE FINANCE OFFICE located at the AST Complex.



Governor's REPORT

Greetings Tribal members,

As you all are aware, the Absentee Shawnee Tribe felt it necessary to revert back to Phase 1 of our Recovery plan on July 27. Following this decision, we began mandatory COVID testing for staff. To date, all tests for essential employees have returned negative. As this newsletter goes to print, we are still testing staff. All staff, both essential and non-essential, must have a negative test before returning to work. If you are an employee and have any questions regarding this policy, please contact your director.

We will move to Phase 2 on September 1. This means the complex will return to full-staffing, and the AST complex will reopen to tribal members by appointment only – no other visitors will be allowed on campus. We will have one entrance and one exit at the complex manned by AST police to perform temperature checks on employees and visitors. For the safety of our members, all staff will wear PPE when they are within 6 feet of another individual.

We are still encouraging members to conduct business by phone or email if possible. If you must visit for business, please call the department and schedule a meeting beforehand. Our high-risk employees will continue to work from home and may not be available for face-to-face meetings.

Lastly, as many are returning to school and work, I would like to urge you to continue to wear your mask and follow the protocol suggested by the Centers for Disease Control. Although numbers are not necessarily dropping, we are not seeing large spikes like we had before. I believe this is due to people taking precautions.

Hello Tribal Members,

Wow! I cannot believe it's already time for another update. As of this writing, I have officially been in my position for 6 weeks. I have been averaging between 55-60 hours of work per week. One thing I can tell you, it has not been boring. Many days, I accidentally miss lunch, as I read emails, answer calls, attend meetings, and receive notices from department heads and staff. Though I run on a tight schedule, I keep times available for members to discuss their concerns.

Recently, the EC voted to modify the Organization Chart. In our discussion, we made a concerted effort to place Departments and Programs under Oversight with experience or knowledge in that field or area. In all, only 4 were moved, and 2 of those were split. Media is now under all 5 of the EC. Additionally, the ad hoc members, or liaisons to committees, commissions or entities were distributed in the same manner. Many of our young people are starting another school year, whether it's Pre-K or as a continuing Higher Ed student in college. At the August EC meeting, we approved the Education Assistance Fund. In an effort to not duplicate services, we decided to assist individuals with issues arising from the Pandemic and Distance learning. Each student will receive a \$500 gift card to purchase a laptop/tablet, printer, ink, paper, extra storage space, software, scientific calculator, or any other associated electronic/educational need. Many of the EC are parents or former students and understand the hardships in trying to obtain an education and doing your best, without having extra worries.

One of my concerns as Treasurer regards the annual Audit. Normally, it is completed by July 31st. However, due to COVID-19 related issues and the Tribal Complex closure, an request was submitted and extension granted to August 31st. The Controller said, "In speaking with independent auditors, we anticipate an "Unmodified Opinion" for all financial and procedural activities for the 2019 fiscal year. An Unmodified Opinion is the highest opinion the Tribe can receive." That is great news for our Tribe, Finance, and all our Departments. Good job everyone!

One comment I wanted to pass along from a conversation, a tribal member exclaimed, "It's weird to see them (EC) working together and communicating. The energy and positive atmosphere that exists is unreal. For once, I feel like they might actually be able to accomplish something."

Honestly, that's the only way I work. As mentioned previously, I'm not here to micromanage or be a dictator. I've explained my vision and shared ideas with staff on how I think we can improve. I also allowed them to contribute to the conversation. They're the professionals with their degrees and expertise. I simply provided the direction and reminders about customer service and in the performance of duties. I will close by again expressing my gratitude. Though some days are tougher and more hectic than others, I am grateful to have this opportunity to serve our People. I simply ask our folks to give us time to acclimate to this new environment. The issues or concerns were here before the election and were not created overnight. Likewise, finding solutions will not happen immediately. Only with proper planning and preparation will we be able to accomplish great things for our Tribe.




Congratulations

Representative's REPORT

Ho wa se ke sa ke! (Good day)

During this national pandemic and nationwide slow down, I can report the AST Executive Committee continues to remain very busy. I have been in office a little over a month and I continue to familiarize myself with tribal processes, tribal member needs and concerns, COVID-19 updates and various tribal board meetings.

As with a new Executive Committee entering into office, we held a Special Meeting on Thursday, August 6, 2020, to update the organizational chart. Through several informal meetings and presenting of drafts, we agreed on a format which best suited our skill-sets and experience as oversight for the various programs. We comprehensively agreed to have oversight of all boards, commissions and committees for greater transparency and access to information, however, we also continued with the liaison appointments for daily/weekly interactions due to our active EC schedules and again for greater information dissemination amongst the EC. There were also 2 additional agenda items which were in relation to expenditures for COVID-19 funds for the Department of Safety. More information was requested and both resolutions were tabled. We all understand COVID-19 funds must be expended by 12/30/2020 and funds used for ineligible purposes become a debt that must be repaid to the Treasury Department. When reviewing the existing priority list we carefully consider if the items are necessary expenditures in relation to the pandemic. The priority listing is always evolving and changes based on the actual needs of the tribal membership. Everything takes planning, short and long term. Before a decision can be reached, all the available data must be presented to make informed decisions on behalf of the tribe each and every time.

The EC jointly worked on the AST Education Aid Program for our tribal students (pre-k to college) for their various education and technological needs due to COVID-19. We also passed by resolution at the monthly EC meeting held on August 19, 2020. During the planning, discussions were held and it was concluded if we pursued laptops we would be caught up in the order back log some area schools were experiencing and we needed to aid students as quickly as possible. Card distribution events were held on Friday, August 28st (Thunderbird Casino-Norman Event Center Awning) and Saturday, August 29th (AST Complex). Applications will continue to be accepted until September 30, 2020 for this school year. If you have any questions regarding this program, an email has been set up for tribal member inquiries: educationaid@astribe.com.

We also worked to further develop a temporary hazard pay policy for our employees who have been serving our tribal people and the public during this wave of COVID-19. We appreciate our employees who continue to do the work they do to keep our programs functioning including putting themselves and their health on the line. The pandemic has been difficult for all and this is an avenue to recognize those who are stepping up to help serve our community. This policy was presented and passed during the regular monthly EC meeting held on Wednesday, August 19, 2020.

At the time of this published article, the tribe will have moved into Phase 2 of the AST Recovery/Reopening Plan and all staff has completed a COVID test. Each department has implemented safety measures for their respective areas and the reopening plan outlines the following for staff and visitors:

- Full staffing (non-essential) will return to each department.
- No Business Travel.
- For employees, personal travel out-of-state must be reported to Department of Public Safety.
- AST Complex will open to tribal members by appointment only, no other visitors allowed on campus.
- Maintain one entrance and exit at the complex manned by AST Police to perform temperature checks.
- Employees are to maintain 6 feet between each other while working and supervisors should adjust schedules or work areas to accommodate.
- All staff on campus will need to wear assigned PPE (mask) when within 6 feet of another individual.
- Curb service or electronic service is still encouraged. If tribal members must enter a building for business purposes, please only allow 2 tribal members at a time. No children are allowed.
- Vulnerable individuals should remain working remotely.

The AST Cultural Preservation Department's gift shop is also now open to tribal members by appointment only. The gift shop manager has been working diligently to refill the current stock. An assortment of new logo bearing merchandise will be available for purchase such as t-shirts, hats, cups, polo shirts, and cardigans. Also, there are new shipments from Pendleton, Crazy Crow and El Paso Saddle Blanket and an assortment of beadwork. In addition to the new products, currently, there is a 20% sale on last season's Pendleton products and Minnetonka Shoes along with some previous season zip up hoodies and long sleeve shirts - still available for \$5.00. Sizes vary from 2X and up. So, please call and make an appointment to shop with Mrs. Rodriguez. She can be reached at (405) 275-4030 ext. 6310. In conclusion, I want to provide my deepest condolences to those we have lost in the month of August, prayers for healing to those who are dealing with COVID-19 diagnosis/illnesses and to those who are suffering from illnesses in general.

I also want to wish the best of luck to all of our children, teens and young adults who are returning to the classroom or who have opted to learn virtually. Challenges lie ahead but you are strong and resilient and you too shall overcome all that is going on around you. Be strong, be safe and have a healthy September.



- Please include copies of your CDIB, valid Oklahoma driver license, current Oklahoma insurance.

OPTION #3- BY EMAIL tax@astribe.com

- Please include copies of your CDIB, valid Oklahoma driver license, current Oklahoma insurance.

PAYMENT OPTIONS FOR ALL TRANSACTIONS

- Payments accepted at this time: Check, Cashier check, Money order, Credit or Debit card. **In order to process by Credit/Debit, we will need the Credit Card Authorization form located on www.astribe.com or forms will be next to the drop box.**

3. Once signed Application is received we will complete the process.
4. All items will be mailed to you. Includes: AST Title, Registration, Application, Receipt, and Tag.

2020 Census Snapshot — American Indian/Alaska Native

What is the census?

Every 10 years, the United States counts everyone living in the country on April 1. Our tribes do not share enrollment numbers with the government, so it is important for all American Indians and Alaska Natives to participate in the 2020 Census.

What's in it for me?

The 2020 Census is an opportunity to provide a better future for our communities and future generations. By participating in the 2020 Census, you help provide an accurate count of American Indians and Alaska Natives. Your responses to the 2020 Census can help shape how billions of dollars in federal funds are distributed each year for programs and grants in our communities.

The 2020 Census is our count. Our responses matter. Regardless of age, nationality, ethnicity, or where we live, we all need to be counted.

Responding to the 2020 Census is:

> Easy

In early 2020, every household in the United States will receive a notice to complete the census online, by phone, or by mail.

> Safe

Your responses to the 2020 Census are confidential and protected by law. Personal information is never shared with any other government agencies or law enforcement, including federal, local, and tribal authorities.

> Important

The federal government and local American Indian and Alaska Native leaders and decision-makers will use 2020 Census data in a variety of ways that can benefit Native people and our communities.





Frequently Asked Questions

> Q. Who should complete the census questionnaire?

A. One person in the home should complete the questionnaire and include every person living there, including relatives, nonrelatives, babies, and children.

> Q. How can I answer the race question?

A. An individual's response is based upon self-identification. You may mark one or more of the race categories and/or enter multiple tribes or multiple detailed groups. Each write-in area will record up to 200 characters and up to six detailed groups.

> Q. What kind of assistance is available to help people complete the questionnaire?

A. Assistance responding to the 2020 Census will be available on 2020census.gov and via our toll-free phone number. Language guides, language glossaries, and language identification cards will be available in 59 non-English languages. Large-print guides to the questionnaire will also be available upon request, as well as telephone devices for hearing impaired. On 2020census.gov, video tutorials and how-to resources can help you complete your census form. Many communities, partners, and local organizations will also provide assistance.

> Q. How does the Census Bureau count people without a permanent residence?

A. Census Bureau employees work extensively to take in-person counts of people living in group housing, like college dormitories and shelters, as well as those experiencing homelessness or who have been displaced by natural disasters.

2020 Census Key Dates



January-April 2020

First census enumeration takes place in Toksook Bay, Alaska.



March 2020

Census notices are mailed or delivered to households.



March-May 2020

Census takers visit each household to update address lists and collect information on the questionnaire.



April 1, 2020

Census Day



*May-July 2020

Census takers visit households that have not completed the questionnaire.



December 31, 2020

By law, the Census Bureau delivers population counts to the President for apportionment of congressional seats.



March 2021

By law, the Census Bureau completes delivery of redistricting data to states.

Cultural Preservation Update

The Cultural Preservation Department has continued to carry out essential day to day operations to ensure the department continues to function properly. Currently, we have three staff members working daily in the office from 8 a.m. to 5 p.m. These staff members include the Director, the Administrative Assistant and the Gift Shop Manager. The remaining three staff members (THPO, THPO Specialist and Librarian) are working remotely Monday through Friday from 8 a.m. to 5 p.m.

Gift Shop

The Gift Shop is currently closed to all visitors. However, in accordance with the Tribe's protocols, once Phase II is entered, we will be allowing tribal members to come in and shop by appointment only. However, to ensure the safety and protect the health of all, the gift shop has implemented the following 5 safety protocols that we ask visitors to follow:\

1. All are required to cover their mouth and nose with PPE (masks) when shopping in the Gift Shop.
2. Occupancy Control – for your safety and the safety of our employees, we are limiting the number of customers in the gift shop.
 - a. **Only 2 customers** will be allowed in at a time.
 - b. **NO children allowed.**
3. Avoid close contact (Social Distance)
 - a. Please keep 6 feet between you and other customers
4. Use hand sanitizer as often as possible
5. Sorry...NO public restroom is available. Temporarily closed due to COVID-19.

We have also placed decals on the floor to help with social distancing, have had plexiglass installed in front of the register for protection and hand sanitizer stations have been installed for use.

During the last month, the Gift Shop Manager, Mrs. Merry Rodriguez, has been working diligently to refill the current stock. We have an assortment of new logo bearing merchandise available for purchase such as t-shirts, hats, cups, polo shirts, and cardigans. We also have new shipments from Pendleton, Crazy Crow and El Paso Saddle Blanket and an assortment of beadwork.

In addition to the new products, currently, we are running a 20% sale on last season's Pendleton products and Minnetonka Shoes, and we still have some previous season zip up hoodies and long sleeve shirts on sale for \$5.00. Sizes vary from 2X and up. So, please once the tribe enters Phase II, call and make an appointment to come shop with Mrs. Rodriguez. She can be reached at (405) 275-4030 ext. 6310.

Library

The library is currently closed to all visitors. Ms. Casey Wilson, the Librarian, is working on protocols that will ensure the safety and protect the health of all visitors. More information will follow in the future.

THPO

The THPO program has continued working remotely to make sure federal projects do not go un-reviewed. Ms. Devon Frazier, the Tribal Historic Preservation Officer, and Ms. Ashley Brokeshoulder, the THPO Specialist, continues to answer all incoming Section 106 correspondences. They have also taken part in numerous teleconference calls with different federal agencies.

Grants

As previously mentioned in last month's article, in response to the novel coronavirus (COVID-19) pandemic, extensions to all grants were applied for within the department. The extensions were granted, and all grants have been extended for another year to ensure the department is given the opportunity to best utilize and expend awarded funds to the fulfillment of the department's goals.

On July 15th, the department received some good news. The library was selected by the Institute of Museum and Library Services to receive the FY2020 Native American Basic grant. Currently, the department is still waiting to hear if the applications for the THPO grant and the ANA Language grant were selected to receive funding.

Your concerns are important to us. We thank you for the continued support of our department as we continue to make changes to our programs, in order to provide the best service to our Tribal community. What is a Brownfield?



The EPA defines a brownfield site as "...real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of hazardous substances, pollutants, contaminants, controlled substances, petroleum or petroleum products, or is mine-scarred land."



Do you have land that you want to use for a business, park, or for cultural purposes, but are worried about possible contamination? If so, you may have a Brownfield site.

Typical Brownfield Sites Include:

- ◆ Abandoned Factories/Buildings/Homes
- ◆ Burned Homes
- ◆ Buried Dump Sites
