Formula for New Registrations:

Cash Price * 1.25% = Excise Tax + Tag Prices + \$10(Title) = Total

Example: For 2015 vehicle-\$25,999.99 X 1.25%= \$325.00 + \$85.00 + \$10 =\$420.00
