## Tecumseh Square Receives Redevelopment Approval

The tribal owned Tecumseh Square Shopping Center has long been an eyesore but that could soon change. On December 6th, Governor John Johnson and Muhammad A. Khan, Vice President of SMC Consulting Engineers, P.C., presented redevelopment plans to the Tecumseh City Council and on December 7th, received preliminary approval to proceed.

The tribe purchased the property located at 12510 Holly Lane in 1992. The shopping center, built in

1960 was once a thriving retail hub for many years. The center housed retailers such as TG&Y, Newton Walls and Shawnee Products (the Bandage Group).

The property has been vacant for years, but the late Lt. Governor Kenneth Blanchard was determined to bring it back to life.

"All of these plans that we are working on, were Kenneth's ideas. I am happy that we can continue the work that he started," said Johnson "It was a huge step in getting this early approval from the

city of Tecumseh. It means we can move the project forward."

The next step for the tribe is selecting an architect. The tribe plans to use CARES funds to revitalize the property. Plans include creating office space for lease.

"I hope we do him proud and honor the vision that Kenneth had," said Johnson. "I look forward to bringing Tecumseh Square back to what it used to be, what Kenneth wanted to accomplish."

## Governor Johnson Delivers State of the Tribe Address

Governor John Johnson delivered the State of the Tribe Address on November 30, 2021 at the Norman City Council Meeting. Norman Mayor Breea Clark invited Governor Johnson to speak regarding the tribe's progress. "I value our relationship and our partnership that we have in this area of Oklahoma," Mayor Clark said, "I look forward to building on it."

Immediately after Johnson's speech, Mayor Clark gave the State of the City

Address.

Johnson's speech highlighted the tribe's enterprises and future plans. He spoke about the two casinos, the Little Axe and Shawnee clinics, Plus Care, the two day cares, the resource center and the convenience store.

"We were the first casino in the state of Oklahoma. In Little Axe, we are planning to expand our clinic. We are also getting ready to build another clinic in the Shawnee area," Johnson said.

"Also, we have purchased 145 acres across the street from Little Axe schools for future projects including agriculture development programs."

He also shared how the tribe helped the members during the pandemic.

"The tribe received CARES funds and we were able to help our tribal people. We provided general welfare assistance, education aid, energy assistance, food cards and small business assistance."

The tribe is trying to combat

COVID and to this date has given out 8,317 vaccines in the Little Axe and surrounding areas. COVID is still here yet Johnson remains optimistic that the tribe will continue to flourish.

"It's been tough and COVID is not over. We are in the planning stages of what we're going to do next but first we will have to wait and see what this new variant does," Johnson said. "But we are going to make it through this."

## GOVERNOR’S REPORT

John Johnson, AST Governor

Happy New Year!!! I hope everyone enjoyed the holiday season with family and friends. It is hard to believe we have started a new year. Below are a few events that I have attended in the last few months of 2021.

I was invited to attend the 44th Oklahoma Governor’s Arts Awards on Tuesday November 9th. Sixteen individuals and three organizations were honored for their contributions to the arts in Oklahoma. Awards were presented by Governor Kevin Stitt during a special ceremony at the Oklahoma State Capital.

On November 18th I had the pleasure of attending the Oklahoma Hall of Fame dinner at the Cox Business Convention Center in Tulsa. On this night, eight people were given Oklahoma’s highest honor. Since the inception of the Oklahoma Hall of Fame in 1927, 714 accomplished individuals have received this honoree.

On December 6th, I attended and presented the tribe’s plan for the old Tecumseh square building at the Tecumseh City Council meeting. Mr. Muhammad Khan the Vice President of SMC Consulting Engineers, Lt Governor DeLodge, Secretary

Miller and a few other tribal staff members were alongside me. Mr. Khan presented the Tecumseh City Council with the survey of the property. The Council is very excited to see what the future plans are for this building and location. We are now ready for the next step which will be Mr. Khan drawing up the architect plans. This project was a vision of the late Lt. Governor, Kenneth Blanchard and I am working hard to make his vision come to light.

I hope all tribal members were able to take part in the ARPA Winter General Assistance program that had a deadline of December 30th, 2021. The EC and staff worked hard at the 2 day in person events on December 10th and 11th. We had over 2000 tribal members receive gift cards on those 2 days. I want to thank everyone that helped during these events, everything went as planned with no major issues.

I am looking forward to starting off 2022 with new endeavors. I can’t wait to see the forward progress that is planned for the tribe this upcoming New Year. Please remain aware of the new strains of COVID that are starting to spread around the country. Continue to wash your hands and wear your mask to stop the spread of this deadly virus.

## LT. GOVERNOR’S REPORT

Tribal Members,

I want to wish everybody a safe and happy holiday. I hope we continue doing our best to continue staying safe and continue to practice the CDC recommended guidelines to get vaccinated, wear your mask indoors and in public spaces and now its suggested to get the booster shot, if you fall within the requirements. It is said the majority or soon to be majority is the Omicron variant, which spreads faster than earlier forms of the virus.

I want to send my thoughts and prayers to those who have lost loved ones and send words of encouragement to those who are facing difficult times.

A few updates from departments within my oversight. These come directly from the Dir’s and if you have any questions please do not hesitate to contact my office or the directors themselves.

### BIA Roads:

**BIA Roads Director Nahinli Billy**

As of today, we have served 23 families with driveway assistance and we have several more that are in progress at the moment. I have not gotten a huge amount done in the last month since I was out with COVID. Cleveland County has completed several miles of county roads we had discussed last month and are very grateful to AST for helping fund those projects.

### Maintenance:

**Maintenance Director Kevin Kaseca**

The maintenance department has been assembling office furniture and completed 32 work orders since November 11, 2021 and during that time also had new pedestal street lights installed in front of building. The Maintenance Department wishes everyone a Merry Christmas.

### OEH:

**OEH Director Jarrod Lloyd**

From January 2021 to November 2021, OEH has assisted Tribal members with 68 different septic renovations and installations, water well drilling and installations, well renovations, and community water connections. For 2021, we have collected, processed, and recycled 64 bales of shredded office paper and cardboard equaling roughly 48 tons of recyclable waste that has been diverted from landfills. 128 Tribal Response, 106 Water Pollution, 319 Non-point Source Pollution, and GAP Grant Applications have been received and we are now operating under EPA Fiscal Year 2021. We have begun our bi-monthly surface water sampling plan for water bodies within our Tribal Jurisdiction. This data is reported to EPA in an effort to prevent surface water pollution and enable additional Federal funding that will enhance the quality of Tribal water bodies. The cabins and bathhouse at Camp Nikoti are near completion. All project construction and closeout documentation is expected to be completed well ahead of the HUD Designated deadline. We have received proposals from Architects for the new Police Safety Center. Those proposals are currently under review and a firm will be selected and begin work on the design

and specifications in January. Once the design is complete, bids will accepted for a general contractor.

### Wood Cutting Program:

**Project Coordinator Clayton Martinez**

The wood cutting programs application will be available on Monday, December 20, 2021 via AST website. We currently have 29 ricks of mixed wood (Red Oak, Post Oak and Black Jack) and still adding to the inventory. We have assisted three tribal members since I was hired in November and hopeful we can assist more as soon as possible. The department has currently filled laborer positions and will have a full crew at the beginning of the 2022 year.

### BIA Tribal Housing Improvement Program:

## SECRETARY’S REPORT

It is 2022 and may this beginning bring you new happiness, new goals, new achievements and many new inspirations in your life. I am definitely excited to see what is in store for our Tribe and for our tribal people in this New Year.

I would like to quickly report on a couple of December activities. The Winter General Assistance was a quick roll out program. Everything is always super hectic in the last quarter of the year however staff made it work. The in-person event held on the 10th and 11th was simply amazing. In 2-days, we issued over 2,100 cards, which equates to over a million dollars. It was a smooth operation and I could not be more pleased with the coordinated effort of all.

The ICW Department always hosts a Christmas Angel Tree for tribal children in need. This year, there was an inclusion of tribal elders as well. I personally sponsored 3 (I usually sponsor a child every year and I love doing so). However, by early December, staff still had 37 Angels

that were not spoken for – which was concerning. By some divine intervention, an answer to prayers was received. ICW received a call from a business in Norman, OK, who wanted to sponsor all of the 37 unspoken for Angels. So needless to say – the day we all ventured to pick up the toys for these Angels from the business, there were flowing tears of joy. ICW staff was ever so grateful, as I was, and the employees of the business were just wonderful and very welcoming. They were such a friendly bunch. I could not have been happier for our little Angels and for the Christmas they were going to have. Ne yi wa to Cimarron Energy-you are an amazing group!

The Homeowner Assistance Fund (HAF) Program, which will have income guidelines for participation, is expected to roll out very soon. I feel this will be such a beneficial program for ASTs. The funds are provided by the federal government to help struggling homeowners, due to COVID-19, who are behind on their overdue mortgage payments, property taxes, home insurance and utilities. The funds will be capped per household and per assistance but overall is still worth the

participation in this program. The goal of these supportive funds is to assist families so they are able to remain in their homes. We will be creating program advertisements and releasing the communications to the tribal members once staff is hired to facilitate the program. The information will be placed in the tribal newsletter, website and social media – so please be sure to be on the lookout.

The tax preparation assistance program will be hosted by my office this year. My Project Coordinator, Ms. Tina Ontiveros, did such a wonderful job planning and implementing the program last year, she will be spearheading it once again. We are still working to shore up some details but expect to begin the first part of February. We will also advertise this program as it gets closer for tax season to begin.

## TREASURER’S REPORT

Hello Fellow tribal members and family,

Welcome to 2022! I hope all is well with each of you and your families. It is my wish that everyone has a prosperous year, good health, and take advantage of the many programs offered by our Tribe. The one concern I have as January begins, the new Omicron variant of the COVID-19 Virus is really taking hold in the United States. As of this writing, Oklahoma is one of only 4 states to not have any person detected within its borders. Please continue to be proactive and take the necessary precautions to protect yourself.

As the new year begins, my office and programs under my oversight have worked tirelessly the last several

weeks and months to get our paper-work ready for the initiation of our Audits and Year End Closeout Reports. Of course, at December’s Regular EC meeting, the Tribe’s Annual Budgets were approved. The next several weeks will show us how well Directors and Coordinators managed their programs. I look forward to reviewing the data and providing suggestions on how we can improve.

Last month, Rose Rock CPAs was selected to complete our annual audit. Of the businesses who submitted a proposal, this company was the preferred best option. One of the main reasons we couldn’t select our previous auditor is we have been with them for the last 3 years. In following the OMB Circular and GASB accounting guidelines, we had to move on to another firm. Another reason is they are a local company so we wouldn’t incur

major travel and per diem costs.

For those who’ve had a chance to view the video, one will notice this was one of our longest meetings. There were a lot of proposed resolutions on the Agenda and the majority was related to last minute expenditures associated to CARES funding. As mentioned previously, it was my preference to not send any funds back to the U.S Treasury.

Recently, EC had the opportunity to tour the Health System’s new vehicles. I am excited at the opportunities this will provide Health as they will be able to utilize these for Remote Visits in certain high population areas outside our Tribal jurisdiction. Several of the options mentioned for use include: vaccinations, diabetes prevention, COVID-19 testing, and dental visits, to name a few.

In another section, I expect there to

be an update on the Agriculture Department, presented by the Lt. Governor’s office and his staff. Grants Department is actively searching for potential funding (USDA) to help offset costs for this new program. I recently saw the announcement flyer and it was very informational in describing services they will be providing to membership.

As I complete this month’s submission, again I want to say “Thank You!” to membership for their continued encouragement and to our Tribal employees for their daily functions and support. Again, I hope everyone is staying healthy. The Tribal Complex is at Phase 3 Modified, appointments only due to the COVID 19 pandemic. The Executive Committee continues to have a team oriented environment which will only increase the opportunities/ successes of our tribe. Our staff and the staff of other departments also work hard to accomplish the day-to-day tasks. Lastly, I want to give my heart- felt condolences out to all Tribal families who have lost loved ones.

In the Education Department: The Workforce Development team consisting of Lt. Governor DeLodge, Tresha Spoon, Eddie Brokeshoulder, Casey Adams and myself met with

several representatives of the Moore-Norman Technology Center and Gordon Cooper Technology Center. We had an excellent meeting and discussion about their long-term and short-term programs and the different kind of programs that would best benefit the tribe/ tribal members. We also discussed how these centers could customize programs that would also benefit the tribe. These meetings are in reference to the AST Workforce Development and Career initiative

In the Cultural Preservation Department: Cultural Preservation Director, Ms. Carol Butler and I had a virtual meeting with two ANA representatives concerning the ANA Language grant. We discussed some of the challenges that we had in not hiring a Linguist and completing required

activities. The ANA representatives advised they are more than willing to assist us in getting this grant back going. We’ve elected to move the goals/ objective/activities to the second year of this grant. We also met with the Grant Department staff concerning the required reporting process of the ANA grant and concluded the ANA grant is caught up concerning required reports.

In the Gaming Commission: I continue to attend Gaming Commission meetings, where we approve/ disapproved employee/ vendor Licensing requests and researched training opportunities for future employees. Gaming commissioners and I have filled the Executive Director of the Gaming Commission. Congratulations to Tribal member Rebecca Du-

boise as the new Executive Director.

The Youth Camp: The two camp cabins and bathhouse are near completion. There has been some concrete poured at the dining hall parking area. Construction on these projects is coming along with dirt work and some tree cutting continuing at the Youth Camp area.

### YOUTH PREVENTION AWARENESS

#### Physical and Mental Health among Native Americans:

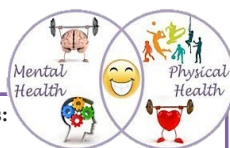
- Suicide is the 2<sup>nd</sup> leading cause of death in Native American youth in the 15-24 age range.
- 22% of females and 12% of males reported having attempted suicide.
- Native Americans experience Post-Traumatic Stress Disorder (PTSD) more than twice as often as the general population.
- Native Americans experience serious psychological distress 1.5 times more than the general population.
- Native American youth have the highest prevalence rate of type 2 diabetes compared to other youth from other racial and ethnic groups.

#### Risk Factors Causing Poor Mental Health:

- High rates of poverty
- Violent victimization
- Historical trauma
- Lack of health insurance and access to appropriate mental health care to address the issues
- Substance abuse
- Native American youth ages 12-17 have the highest prevalence of smoking compared to other racial and ethnic populations.
- Alcoholism mortality is 514% higher than in the overall Native American population compared to the general population.
- Over 22% Native American youth at the age 12 or older have reported alcohol use. More than 16% have reported binge drinking.

#### Warning Signs That Your Child May Be Struggling:

- Child is feeling very sad or withdrawn for more than 2 weeks.
- Showing drastic changes in behavior or personality.
- Getting in many fights or wanting to hurt others.
- Having severe mood swings that cause problems in relationships.
- Using drugs or alcohol repeatedly.
- Not eating, throwing up, or using laxatives to lose weight.
- Showing out-of-control behavior that can hurt themselves or others.

## Absentee Shawnee Tribe Domestic Violence Program

**Domestic Violence Director:** This position oversees all aspects of the Domestic Violence program; ensures consistency of service delivery to victims of domestic/dating violence; sexual assault; stalking and human trafficking. The Domestic Violence Director is responsible for the overall planning, administration and management of the program's services.

**Program Coordinator VOCA:** Determines client eligibility. This position will assist victims in the Transitional Housing Program and assist with cases proceeding through the criminal justice system. This position coordinates the daily operations of the transitional housing program and court advocacy. Assists victims who are fleeing domestic violence, sexual assault, dating violence and/or stalking needing emergency services, transitional housing, protective orders and court cases related to the incident.

**Project Coordinator:** The Tribal Victim Services Coordinator will oversee the delivery of all direct services, grant reporting, grant compliance, and all other oversight pertaining to the administration of this grant and its goals. The Tribal Victim Services Coordinator for the OVC TVS Set-Aside FY20 grant under Domestic Violence Department of the Absentee Shawnee Tribe of Oklahoma will be responsible for the planning, coordination and development of all activities related to the enhancements and expansion of services for victims. Also, the coordinator will work alongside the Domestic Violence Staff to assist with the coordination and management of other victims of crime such as domestic violence, dating violence, sex trafficking and stalking.

**Sexual Assault Coordinator:** The Sexual Assault Coordinator for the Domestic Violence Program of the Absentee Shawnee Tribe of Oklahoma will be responsible for the planning, coordination and development of all activities related to the enhancements and expansion of services for victims/survivors of sexual assault. Also, the coordinator will work alongside the Domestic Violence Staff to assist with the coordination and management of other victims of crime such as domestic violence, dating violence, sex trafficking and stalking.

**Cultural Outreach Coordinator:** The Cultural Outreach Coordinator assists victims/survivors of elder abuse, survivors of homicide, adult victims of child sexual assault/abuse, as well as victims of domestic violence, sexual assault, dating violence, sex trafficking and stalking with their current situation. They will respond to referrals of elder abuse/neglect, complete intakes and provide case management services. Incorporate cultural practices and life ways into the program and develop cultural activities and culturally appropriate healing options for victims of crime. Develop self-care planners and outreach awareness activities.

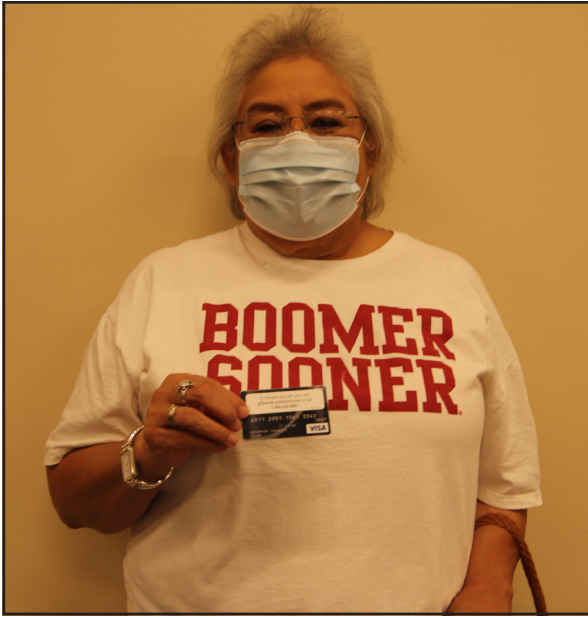

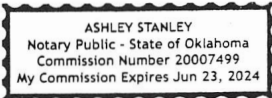

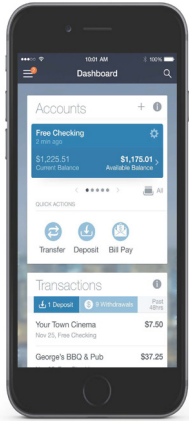

## ASTHS January 2022 Monthly Update

2021 was another amazing and yet challenging year for us all. The Health System completed the final payment on the Joint Venture, retiring the debt several years earlier than anyone could have ever predicted, due in part for the unprecedented growth in our services and to our Native American patients. We also hit several new revenue benchmarked “historic firsts” in the Health System, as well as having another clean annual independent audit report. When the Tribe first compacted with I.H.S. several years ago, the Tribe had a choice of choosing between servicing only AST Tribal members, at a significantly reduced compacted funding level, or to take or receive all of the funding shares to care for all Tribal members of any Federally Recognized Tribe seeking care at our facilities. The Tribe chose the latter, and this has provided the Tribe with increased revenues in areas such as Indirect Cost (IDC) supporting Tribal programs for the Health System, generating of more Third Party Revenues to help fund additional services for the Tribe, and better services for our patients, which in turn generates more Third Party Revenue. The AST Health System’s phenomenal growth hasn’t come without growing pains. To continue servicing patients in a manner they have become accustomed to, (with such programs as after-hours on-demand walk-in clinics, pharmacy drive through, specialty clinic, Affordable Care Act Sponsorships, 100% approval of Medically Necessary Purchased Referred Care Services, Home Health Services, Public Health COVID Vaccinations and Testing), we need to retain a robust capability in delivering these services by adjusting to our unprecedented growth and success. The I.H.S. Compact with the AST Tribe does not fully fund any of these programs, and they have to be augmented significantly with Third Party Revenues. In addition, the AST Health System has taken over the Title 6 Program from the Tribe to ensure its continued viability in servicing AST and other Native American program participants, thus reducing the financial burden upon the Tribe. The value provided by the AST Health System is historic, invaluable and a source of Tribal pride! Today, with more doctors, dentist, other professional staff and support staff remaining year after year with the Health System, has the least amount of overall turnover the Health System has ever had. This is important, as the more stabilized the Health System is, the better effect it has on the patient – who is the center of everything we do. Stability leads to growth, growth leads to prosperity. This is where we are at today, and we are thankful to the Tribe, our patients, and our employees for all they do for our communities whom we serve.

We proudly recognize all of our outstanding star performers, and thank them for their contributions to our patients, their fellow employees, and the Tribe, especially during these challenging times! The AST Health System always strives to make your health its top priority, and you all make a difference for our health system and the health and wellness of all of our patients – “THANK YOU” for all you do! The 2021 Employee of the Year will be announced next month – stay tuned!

## WHO IS ELIGIBLE FOR A 3RD DOSE OF A COVID-19 VACCINE?

#### **MODERNA:**

The Center for Disease Control (CDC) is recommending that moderately to severely immunocompromised people receive an additional dose. This includes people who have:

- Been receiving active cancer treatment for tumors or cancers of the blood.
- Received an organ transplant and are taking medicine to suppress the immune system.
- Received a stem cell transplant within the last 2 years or are taking medicine to suppress the immune system.
- Moderate or severe primary immunodeficiency (such as DiGeorge syndrome, Wiskott-Aldrich syndrome).
- Advanced or untreated HIV infection.
- Active treatment with high-dose corticosteroids or other drugs that may suppress your immune response.

#### **PFIZER-BioNTech:**

The CDC is recommending that only certain populations initially vaccinated with the Pfizer-BioNTech vaccine can get a booster shot at this time:

- Older adults and 50-64 year old people with medical conditions.
- Long-term care setting residents aged 18 years and older.
- People with medical conditions aged 18-49 years.
- Employees and residents at increased risk for COVID-19 exposure and transmission.

People should talk to their healthcare provider about their medical condition and if they meet the above criteria for getting an additional dose.



## MEDICINE WHEEL & 12 STEPS



The medicine wheel and 12 Step program was developed to provide a culturally appropriate 12 Step program for Native American people. This program was developed by White Bison, based upon teachings of the Medicine Wheel, the Cycle of Life and the Four Laws of Change.

### HOW THE PROCESS WORKS

The Medicine Wheel and 12 Step program is designed in a series of modules that enable people to meet their individual needs. Participants watch a video that explains Medicine Wheel teachings and apply them to their lives. In addition, participants share their insights and experiences in a talking circle. They also learn how to mind map their own innate knowledge around these teachings and then apply that knowledge to their daily lives and decision making processes. For those working through the program in a group setting (i.e. Circles of Recovery) very strong social and emotional bonds are created that help the individuals who participate to develop trust, autonomy, and other healthy feelings and thought patterns that will help them to grow emotionally, mentally, physically, and spiritually.

### FOCUS

The focus of the program is on character and values. Thus each of the 12 Steps is presented from the perspective of the value that it reflects.

Step 1: Honesty	Step 5: Integrity	Step 9: Justice
Step 2: Hope	Step 6: Willingness	Step 10: Perseverance
Step 3: Faith	Step 7: Humility	Step 11: Spiritual Awakening
Step 4: Courage	Step 8: Forgiveness	Step 12: Service

### TEACHINGS OF THE MEDICINE WHEEL

The Medicine Wheel is an ancient method for teaching important concepts about truth and life. Many Native American communities use a Medicine Wheel, although the colors and the symbols are different depending upon the culture. The purpose is the same in each culture. These teachings, when applied to one's life, have the power to influence significant change in attitudes, behaviors, values and intent. The Elders have shared a series of Teachings based upon the Natural Order of the way things should be. These are sometimes referred to as the "original instructions." These important Teachings are included in the Medicine Wheel and 12 Steps:

1.) 4 seasons of change	6.) Nature's Way: Principles, laws, and Values	10.) Comfort Zones
2.) 4 laws of change	7.) Cycle of Life	11.) The Two Thought System: Love and Fear
3.) 4 directions of growth	8.) Feelings for healthy development	12.) The laws of the unseen world.

5.) Reclaiming Our Power

- Per Purchase/Referred Care guidelines, all Native American patients must apply for all available resources, if eligible.
- Contact a Patient Benefit Advocate to see if you are eligible for Native American Cost-Savings under the Affordable Care Act.

#### Did You Know?

- The Tribe is only funded approximately 40% of cost to render care to patients? Most people think it is funded 100%.
- To add services, equipment, or help more people, we need your assistance.
- By signing up for a zero cost plan, you allow the tribe to bill for services and to be reimbursed by insurance companies. This frees up more dollars to help those who are not eligible for a zero cost plan helping Purchase & Referred Care dollars go further.

### Kids in the Kitchen

Allowing children to help cook meals helps teaches basic kitchen skills. Not only is it a great way to teach new skills, but it can also be a time to spend more time as a family and learn about the child's day. Also, if a child helps prepare new fruits or veggies, they are more likely to try that new food.

Kitchen reminders:  
Wash hands before touching food. This teaches children the importance of hygiene in the kitchen.  
Watch children when they are using sharp items such as knives, graters, blenders, or mixers.  
Watch children when they are using the stove top or oven.

## YOU MAY BE ELIGIBLE FOR A \$0 COST HEALTH PLAN UNDER THE AMERICAN RESCUE PLAN.

Help yourself, help your tribe and see if you will qualify for coverage that will provide you and your family with immediate access to specialized healthcare at no cost to you or your tribe.



Did you know? The American Rescue Plan (ARP), recently signed into law by President Biden, increases and expands eligibility for cost-savings programs under the Affordable Care Act (ACA) in the form of premium cost assistance for individuals enrolled in Health Insurance Marketplace plans.

The premium assistance is in the form of a IRS Advance Premium Tax Credit taken in advance of the tax year, lowering or eliminating health insurance premiums for lower-and middle-income families. Signing up for a low-or-zero cost health plan allows tribes to receive reimbursement for services, which frees up more dollars to help those who are not eligible for cost-savings programs, helping Purchased Referred Care dollars go further.

Native Americans must apply for all available resources, if eligible, to help augment the cost of tribal healthcare services. Program rules and continuity of care necessitates completion of an annual application for benefits to assure services are covered, even if ASTHS patient is already insured.

## Under 65? Apply for SoonerCare With New Medicaid Expansion.

AST Tribal Health System and the Oklahoma Health Care Authority are pleased to announce effective July 1, 2021, Oklahoma is expanding Medicaid for adults ages 19-64 with incomes at or below 138% of the federal poverty level. **Per Purchased Referred Care guidelines, all patients under 65 years old, whether insured or uninsured, must apply for Medicaid Expansion benefits effective July 1, 2021 to help augment the cost of tribal healthcare services.** Help yourself, help your tribe and see if you and your family will qualify to get coverage at no cost to you or your tribe.

Program rules and continuity of care necessitates completion of an annual application for benefits to assure services are covered, even if ASTHS patient is already insured.
