



# FAVORABLE RULING FOR THE ABSENTEE SHAWNEE TRIBE

On November 14, the Absentee Shawnee Tribe obtain a favorable decision from the Interior Board of Indian Appeals in the probate case – the case which concerns which tribe is the "tribe with jurisdiction" over the Absentee Shawnee trust allotments. The IBIA ruled that the Absentee Shawnee Tribe is the "tribe with jurisdiction" and the ruling upheld the Absentee Shawnee position in all respects.

The case involves probates of lands allotted in the late 1800's to members of the Absentee Shawnee Tribe. These trust lands have always been subject to the exclusive tribal jurisdiction of the Absentee Shawnee Tribe. Under the American Indian Probate Reform Act (known as "AIPRA"), when an Indian passes away without a will and without eligible heirs, certain interests in trust lands pass to the "tribe with jurisdiction" over those lands. The term "tribe with jurisdiction" is not defined in AIPRA. Beginning a few years ago, a series of probates raised the issue of which tribe is the "tribe with jurisdiction" over the Absentee Shawnee trust allotments.

The Absentee Shawnee position is that the Absentee Shawnee Tribe is the <u>only</u> tribe that exercises actual jurisdiction over the Absentee Shawnee trust allotments, and this has always been the case. These lands were set aside by the United States for the Absentee Shawnee and have been in Absentee Shawnee ownership and under Absentee Shawnee governmental authority for generations. That is all that is needed to resolve the case.

But Citizen Potawatomi participated in the case and claimed that somehow they are the "tribe with jurisdiction." Citizen Potawatomi does not claim that they exercise jurisdiction over Absentee Shawnee trust allotments today – or that they have ever done so. Instead, they argue that the Collier case somehow made Citizen Potawatomi the "tribe with jurisdiction" over the Absentee Shawnee trust allotments. Of course, as the Absentee Shawnee Tribe has argued throughout the case, Collier involved only the process for taking fee land into trust, and had nothing to do with which tribe has jurisdiction over these Absentee Shawnee trust allotments.

In a 2011 ruling, an Administrative Law Judge (Judge Reeh) agreed with the Absentee Shawnee Tribe's position, and rejected the Citizen Potawatomi position. Citizen Potawatomi then appealed that ruling to the IBIA.

The IBIA has now issued its decision. The IBIA ruling provides an excellent summary of the historical background of the 30-mile square. It contains an important discussion of the Collier case – clearly stating that it only applies to fee-to-trust issues, and has nothing to do with jurisdiction. And the IBIA decision concludes that Congress intended the Absentee Shawnee Tribe to have jurisdiction over the Absentee Shawnee trust allotments.

We are very pleased with the decision, which strongly supports Absentee Shawnee jurisdiction and sovereignty.

Let's Build For the Future (BFF)

Season's Greetings, my Absentee Shawnee people!

Governor

In January the Election Commission will begin to take applications for those interested in serving on the Executive Committee. As you may be aware every 2 years part of our elected body must run for Office again and/or must apply for the Offices that are open. This year those Executive Committee positions are: Lt. Governor, Treasurer and Representative. Our Constitution governs the duties and responsibilities within these official positions and I am finding that one must be dedicated and truly want to serve and represent you and your interests. In our roles as elected officials we have sworn duties and took an oath to uphold that commitment and this means to me that we (as elected officials) must be honest and sincere in our efforts. It is my hope that you, our Tribal members, consider that when you are voting. It is vital to this Tribe that the right people be placed into these elected Office's that are dedicated to moving the Tribe forward and not just in getting a paycheck. We as leaders should be good representatives for you the people and shouldn't harass or allow harassment to occur to our employees; drink and drive; neglect our duties at our respective offices by not coming to work or come in whenever we would like to; and not inconsistently attend Executive Committee meetings.

Instead we should be role models to our staff by being here timely each day in our Offices to me that means being here each day from 8 to 5 (at a minimum); work with our staff to advance service levels by supporting continuous training initiatives and incentivize excellent work; advertise for and hire qualified applicants and rely on their expertise to guide us as leaders; and I find that it is very important for elected officials to be at the Executive Committee meetings.

The Executive Committee, the Attorney General and my Office are currently working on a Code of Conduct – Ethics Policy which will hold us, as elected leaders, to the high standards required of our Offices. This policy will be placed on the January Regular Executive Committee meeting schedule.

The concerns the Election Commission brought up during the October General Council meeting is to be addressed by our Attorney General. The AG has advised that he spoke with the Election Commission and has offered to sit down with them. At this time a time and date hasn't been set.

The child support enforcement and legal services issue with the Modoc tribe and their legal firm has been resolved for the time being. There appears to be a new line of thinking going on with the Modoc tribe as they have placed a different legal firm under their Memorandum of Understanding (MOU) agreement that ensures AST receives child support enforcement and legal services other than with the former firm our Tribe separated from. We will continue with the Modoc Tribe agreement unless they revert back to that former legal team.

# **Emergency Management**

This month the Emergency Management Coordinator offered a training plan for Tribal Employees to my Office for the Executive to consider. This proposed plan is as follows:

1. Each full-time employee must take NIMS 100 & 700 courses by a set deadline

- 2. Dept. heads are responsible to track compliance and submit to Emergency Management Coordinator.
- 3. Directors, Coordinators, and Managers are required to take NIMS 100, 200, 700 & 800 by a set deadline.
- 4. Any employee that has completed the required NIMS courses will be given an incentive reward for completion, i.e. gift card or certificate)
- 5. All new employees will be advised this is part of their employment.

These courses provide training for tribal personnel to obtain a basic understanding of the Incident Command System (history, features, principles and organization structure) that is used during a disaster. The more we learn the better prepared we are when we are faced with a disaster situation.

# LT. GOVERNOR'S



I hope everyone had a good Thanksgiving and a Merry Christmas, as the Holiday Season is a time for family and giving thanks to what is important in our lives. I would like to thank the Maintenance staff for their hard work during this last round of winter weather. # TRUST ADMINISTRATION CLASS PAYMENTS EXPECTED IN EARLY 2014

Important Update: Trust Administration Class payments are expected to be mailed in early 2014.

The Settlement Agreement approved by Congress and the Courts requires identification of all Trust Administration Class Members and calculation of their respective pro rata shares before the Claims Administrator for the Cobell Settlement can mail Trust Administration Class payments. That work is ongoing and is nearly complete.

After the membership of the Trust Administration Class is finalized, it will take approximately a month to complete the calculations for the over 500,000 Trust Administration Class Members. Once the Claims Administrator receives those calculations and the Court approves the Second Stage Distribution, the Claims Administrator will quickly prepare and commence distribution within three weeks.

Thus, if the class membership is finally determined in December, the payments can then be made in the first quarter of 2014 barring any unexpected issues. Please be assured that all parties are doing everything possible to issue the Trust Administration payments as soon as possible. Any questions can be directed to the below:

The Roads Department is currently working with the awarded contractor and engineering firm, to begin construction on the new AST Police Sub-station parking lot, located between the Tribal Store and Community House in Little Axe. The parking lot will not only be used by our Tribal Police, but our store patrons and those using the Community House as well. Construction will begin within the next few weeks, as weather permits, and will not disturb the Tribal Cemetery. During the construction period, activities will be limited at the Community House. In the event funeral services are held at the Community House, construction will cease out of respect for families.

My office has also started the process of replacing the old Community House by obtaining approval from the Bureau of Reclamation to move and replace the old Community House. We are putting a more user friendly building in its place for the different activities held there. It is a well-known place in the Little Axe Community and has seen many years of activities. The house will be moved to another tribal location to make way for the new Community House.

The Tribe received some very good news in regards to the "Tribe with Jurisdiction" Probate Appeal case. The case involving the Absentee Shawnee and Citizen Potawatomi, questions which "tribe with jurisdiction" is over Absentee Shawnee trust allotments under the American Indian Probate Reform Act (AIPRA). In a November 14, 2013 Order Denying Rehearing, the

Interior Board of Indian Appeals (IBIA) ruled the Absentee Shawnee Tribe is the "tribe with jurisdiction" over Absentee Shawnee trust allotments. As in a previous article, the Citizen Potawatomi claimed to be the "tribe with jurisdiction" over all trust lands within the 30 square mile boundary. Once again we have defeated the Citizen Potawatomi and their notion they have jurisdiction over our lands.

The ruling provided a very detailed and excellent history of how our lands came to be. The history goes as far to show the Absentee Shawnee was in this area 20 years or more before the Citizen Potawatomi; our established land base in the mid 1800's was south of the North Canadian River and north of Little River; the Potawatomi gave up rights as "Indians" and had to pay for their allotments; and the true "squatters" are the Citizen Potawatomi.

The ruling also referenced the controversial Collier Case. The question in Collier is whether the AST are able to place land into trust. For years the Citizen Potawatomi has led many to believe the Collier Case is about tribal jurisdiction, when really it is a question of placing land into trust.

The Probate ruling affirms that probates case with undivided interest and no eligible heirs will go to the "tribe with jurisdiction". So, in AST probate cases where there are undivided interest and no eligible heirs, the Absentee Shawnee Tribe will be awarded the interest.

This ruling strongly supports our tribal jurisdiction and sovereignty, in a time when tribal sovereignty is slowing being taken away.

• Financials for Tribe, Audits, 2010-2012, are "unmodified" opinion (which when compared to education grading rating scale is an A. Indirect Cost Proposal for 2014 has been submitted to the Interior Business Center (IBC)

and is ready to be assigned to a negotiator. Current 2013 rate is 27.39% with 2014 being undetermined until negotiations during 2014. We are preparing for the 2013 Audit which will begin early 2014 for all of the Tribes' entities (Casinos, Store, Restaurant, Smoke Shops, ASEDA, Inc. and Enterprises, ASTHA & LSWN which makes up Absentee Shawnee Tribe Health Systems, and the Tribal Government) All of the tribes entities must be audited first

# FINANCIAL CONSULTANT'S

Hope everybody had a Merry Christmas and wishing each of you a prosperous 2014 New Year! As the office of Treasurer begins year 2014, it is our hope that we continue to provide you transparent fiduciary financial information and continue to improve progress of our tribe.

The following activities I have been involved in and participated:

Financial Reports: Reviewed and analyzed monthly General Fund, Indirect Fund encumbrance monthly budget reports.

Absentee Shawnee Economic Development Authority, Inc. (ASEDA): ASEDA last board meeting was held, discussion centered on Little Axe Water District development project and a business venture discussion of local Clemence Tire dealership in Tecumseh, OK.

ASEDA 2014 budget was submitted to Executive Committee for approval. ASEDA looks toward 2014 as a year of opportunity to progress in economic development utilizing USDA funding for business development.

#### **COMMUNITY ENGAGEMENT**

U.S.D.A. Community Food Projects Grant: Participated in a free webinar sponsored by First Nations Knowledge program titled "I'm Thinking of Applying for the USDA Community Foods Projects Competitive Grants Program. Since 1996, the USDA Community Foods Project Competitive Grant has supported projects looking to promote sufficiency and food security in low-income communities.

Programs are aimed to unite the entire food system, assessing strengths, establishing linkages, and creating systems to improve self-reliance over foods. A power point presentation was provided to each webinar attendee by Vicky Karhu, Independent Consultant, topics covered James Lankford picture

U.S. Congressman James Lankford, Oklahoma 5<sup>TH</sup> District: Attended Tuesday Talk town hall meeting with Congressman James Lankford, Gordon Cooper Vo-Tech, Shawnee, OK, with Governor Edwina Butler-Wolfe and her son Josh Gibson. Congressman Lankford addressed current issues with constituents and gave them a chance to ask questions. The OKBFRP program is sponsored by Mvskoke Food Sovereignty initiative (MFSI), Oklahoma Farmer and Rancher Association (OFRA), Oklahoma State University Cooperative Extension Service and Rural Smallholder Association (RSA).

FINANCE DEPARTMENT

The Finance office continues our efforts in keeping the day to day activities flowing effectively and efficiently through communication between the Finance office and Programs. In working together, we have found the most time effective and cost effective processes for transacting business.

The Tribe's 2010, 2011, and 2012 Audits are "unmodified" opinion; which when compared to an educational grading scale is an A. The 2014 Indirect Cost Proposal has been submitted to the Interior Business Center (IBC) and I was notified this week that it is ready to be assigned to a negotiator. Our rate is up from 17.74% for 2010 to 21.98% for 2011 to 22.35% for 2012 and 27.39% for 2013; with 2014 being undetermined until negotiations during 2014.

We are preparing for the 2013 Audit which will begin early 2014 for all of the Tribe's entities [Casinos; Store; Restaurant; Smoke Shop's; ASEDA, Inc.; ASEDA, Enterprises; ASTHA & LSWN which makes up Absentee Health Systems; and the Tribal Government.] All of the tribe's entities must be audited first and then they are combined with the Tribe's Governmental Audit.

The finance department, for 2013, is completing accounting by the 10<sup>th</sup> day of the month which has been extended from the 7<sup>th</sup> allowing the health finance to provide reports necessary for adjusting inventory and accounts receivable. Financial reporting for the Health Authority and Li Si Wi Nwi, Health Inc. boards for Absentee Health Systems, Shawnee and Little Axe (LSWN) continues monthly. The Finance staff has completed the November reconciliations and financials. It is imperative the accounting staff continue to stay ahead of all of the accounting so that audits go

smoothly, and Indirect Cost rates stay up to date. Indirect cost proposals cannot be submitted without completed audits as the audit is used to calculate the proposal. There are many processes in place in your Tribe's accounting department that ensure we keep accurate records of transactions. The Tribe's accounting processes must be in compliance with GAAP; (Generally Accepted Accounting Principles) and GASB (Governmental Accounting Standards Board) and these rules are updated annually.

The Tribe currently has compact funds of BIA, I H S, and approximately 51 Grants. In addition, the Tribe operates a General Fund and an Indirect Cost Fund. The new clinic building payments are current and have not been late and projections are that they will continue to be current going forward

The Absentee Shawnee Tribe's Finance Department has very hard working group of people and it is an honor to work with them, the Treasurer's office and at the Absentee Shawnee Tribe. The Finance Department employs 14: with 6 (43%) being AST Tribal Members, 2 (14%) non-AST tribal members, 6 (43%) being non-natives.

# AST Constitution Revision Committee Report

The AST Constitution Revision Committee was established in September 2008 under the Executive Committee at the time.

The Committee was made up of volunteers who were willing to work on revising the Constitution and give their input and time. There were many volunteers over the years and different EC members but the Constitution Revision Committee has continued to work on the revising the Constitution. The members and the EC at the time felt a revision to the Constitution was necessary for the advancement of the Tribe and to make the business aspect of the Tribe more profitable and productive. The intent is to revise the Constitution so that it suits the need of our Tribe and our people. The current AST Constitution is based on a template that was given to all the Tribes to use and has been in place since 1988. Much has changed since then.

With a revised Constitution, the hope is to have a more stable, economically sound and self-sustaining government for our future generations.

The Constitution Revision Committee will be meeting in January to begin the discussion on the final articles of the revised Constitution.

The CRC feel we are to the point of making final changes and then soon after going into the review process.

The AG and BIA will be sent a copy of our revised Constitution so they can tell us if we need to make changes or if more discussion is needed. Once the review is complete we will present the revised Constitution to the people and to the Executive Committee. Then the EC will have the option to pass a resolution agreeing that the revised Constitution be sent to the BIA for a referendum vote of the people.

The BIA will set up the referendum vote with the assistance of the AST. This has been a long process and we would like to thank all of those that have stayed involved and continued to be patient with the process. We would not have made it this far without out the dedication and determination of these committee/Tribal members!

If anyone would like to attend the meetings and assist us with the final revisions they are more than welcome to attend.

As we have always said this is the Constitution for everyone so as much in put as possible is greatly appreciated.

A Severe Weather Policy for the Tribe is forthcoming. This policy is to be on the December Regular Executive Committee meeting agenda. This will give the Tribe a policy to go by during extreme weather conditions and allow for the Executive Committee to decide on the closure of the tribe. At this time closure of the Tribe is based on school closures. This needs to be changed so that the business of the Tribe may occur. We are a Tribe but we also are a business and service needs don't stop. We employ staff to take care of our programs, functions and services. In 2014 the Emergency Management Coordinator position is to become full time (if I can get the budget in place) and be placed within a full functioning office of Emergency Management (EM). During the tornado disaster we were caught without an EM plan in place. We have had extreme weather issues before but the tornado disaster was one that made it clear we needed an office and staff in it. This office in 2014 will do the following:

With the EM Coordinator in place more time will be devoted to meet the goals of Emergency Management for the Tribe. There are several items that need to be addressed. The most important one is our Tribal Hazard Mitigation Plan on file with the Region VI FEMA Office.

1. The Tribe's Hazard Mitigation Plan that was approved by FEMA in 2010 is good for five years and will expire in 2015. The plan outlines our proposed actions to mitigate natural hazards. The EM Coordinator will meet with the Region VI Mitigation Officer to go over the Plan and update it. The mitigation activities outlined Plan needs to be completed and updated so that the Tribe will be eligible for Pre-Disaster and Post-Disaster Mitigation grant funding. The Timeline: 1st qtr. of 2014 (contingent upon coordination with Region VI Coordinator schedule).

2. Coordinate with the Tribal Grant Coordinator this month to write grant proposal(s) for mitigation funding will be on an ongoing basis.

## **Law Enforcement**

On Nov. 23, 2013 the Police Department participated in the Clinic Fall Fest, which allowed children to be fingerprinted for personal Identification cards.

As of Nov. 13, 2013 the Police Department started using a web based software to enhance tracking of calls and to serve the Absentee Shawnee Tribal members with better service which includes, allowing the officer to take reports and keep logs of activity without leaving their patrol unit. This should improve the efficiency of our taking calls for the Tribe. Thus far this web based software is a success by better kept records and serving the public.

# **Building Blocks & CCDF**

CCDF:

This month Billie Thompson, Building Blocks (BB) Director and Briana Ponkilla, the CCDF Project Coordinator, attended the CCDF New Administrator training in Dallas, TX. They learned more about the grant and how to administer the program as well as incorporate quality care in the facilities and through our providers.

The AST CCDF program utilizes the Data Tracker program for data processing of the CCDF subsidy program. For the program year we had 26 children who received child care assistance through the subsidy portion of the CCDF grant. All providers have been compliant with our guidelines and processes for payment.

BBII is licensed for 90 children and currently have 58 children enrolled with 29 of those children being Native American. We have 18 people on staff; a Director, an Assistant Director, a Food Service Specialist and 15 Teachers/Floaters. We will be adding a few more children by the end of 2013. We would like to add more children to reach our capacity but we are finding the need to keep open spaces for current enrollees due to the lack of spaces for those who are transitioning into the older rooms. Due to DHS ratio guidelines and the floor space of our current rooms we are not able to reach our capacity. We strive to fill each room while still being in compliance with DHS. It may seem like we are not filling up the rooms but there is a reason we keep the enrollment where it is. We feel it is a necessity to incorporate more after school programs in our current system to accommodate higher enrollment for the younger children. Enrollment is an ongoing process we work on weeklv.

BBII does enroll off a waiting list. Currently there are 104 native children on our waiting list from Infant to After School age. The After School waiting list consists of 40 Native American children who are waiting placement in our BBII Center. There is a great need for After School programs in our area to offset the burden that parents face with childcare needs after school from Infant to After School age. For 2014, we have joined the Let's Move Child Care initiative for the center and will be working with the kitchen staff to ensure we meet those recommendations.

There has been progress in the construction of the BBIII program in the Little Axe area.

There are a few modifications that we are working on but they are merely storage space issues and will not affect the classrooms or child care areas.

We have started a waiting list for BBIII and will start advertising more as the opening of the center gets closer. The anticipated opening date of this facility is June 2014. We feel the need for a center in this rural area will be beneficial to the AST and Little Axe community.

Building Blocks had a very busy December as they prepared for Christmas. Their Christmas Program was on Monday the 16th. It was a huge success! The children and teachers worked very hard on their songs. We provided refreshments for the families.

Our Master Teachers are in the process of completing their Early Learning Guidelines Training, which is a requirement of our Stars Program. This training details the foundations of learning and how we can support those areas through our daily activities. I am also attending these trainings as a way to support my staff and to educate myself on these guidelines so that I may monitor their incorporation into our program.

As a part of staff development, I have presented the teachers with a challenge and that is to create a prop box for their classroom that is age-appropriate. This would be used as a dramatic play area. The activities must incorporate career ideas, reading/writing opportunities, and materials that encourage exploration and cooperative play. For example: A flower shop would contain flower pots, empty seed packets, plastic flowers, pictures of different flowers with the name printed below, hats, gloves, shovels, sand table, order pad, cash register and play money. The children play cooperatively as store owner and customer.

The empty seed packets and labeled pictures introduce new words and encourage reading, while taking an order improves writing skills. The cash register transactions introduce math concepts and the overall play increases social skills. The main part of the challenge was to find as many materials as they could from free resources. Parents have offered to donate items to many of the prop boxes, which allow the parents a chance to be involved in what we are doing here at Building Blocks.

Building Blocks continues to make great strides forward to improve child, family and staff satisfaction. Great compliments continue to be received pertaining to the improvements from parents and teachers. We are looking forward to see what 2014 brings!!!

On December 10th and 11th, Tresha Spoon, Director and Blake Goodman, TYP Coordinator attended the Oklahoma Council on Indian Education's Annual Conference. This conference addressed issues regarding Indian Education funding, programming ideas, data collection/survey results, and OCIE's mission to increase the scope of its efforts across the state and nationwide. Tresha attended the Oklahoma Council on Economic Education's Annual meeting on December 13th. Tresha has been a board member since 2006 and sits on the Council's Budget and Finance Committee. Following the OCEE Annual meeting, Tresha, along with the Governor and Lesa Shaw attended a Listening session hosted by the Tribal Education Department National Assembly (TEDNA) in partnership with the US Department of Education, the Bureau of Indian Education (BIE), and the South Central Comprehensive Center at OU. The Listening session was for tribe's to voice their comments, suggestions, and concerns with all areas of Indian Education. As the Governor I entered bullet points into the record on behalf of the Tribe.

December 12th TEDNA hosted a workshop with the BIE to demonstrate the Oklahoma State Department of Education's data sharing tool. Also, the BIE provided a template on creating an agreement with the BIE to facilitate the sharing of student data that is compliant with the Family Educational Rights and Privacy Act (FERPA). Tresha is a Board member on the TCAP Advisory Board. The Board meets the third Thursday of the month at 8:30 am in the AST Tribal Court.

The purpose of our first food sovereignty meeting was to bring together a


group of concerned individuals, various programs, elders and community members who are interested in the development of a Food Sovereignty organization.

or action has been taken or process addressed, and the review of all issues are completed, the Health Director, Mr. Rogers and/or his designee, will personally contact each caller with updates, decisions, or questions pertaining to how the case was fixed or addressed. This will allow the leadership to expedite your concerns efficiently and concisely, as well as monitoring and tracking the overall improvements in our services to the tribe

We are also updating our customer service feedback cards at the clinics and will begin reporting them on a monthly basis beginning in Jan 2014 to the Governor's office and to the Health Boards for visibility on action(s) taken.

We are looking at entering into an agreement with the Veteran's Administration (VA) with eligible services for our tribal veterans to begin in early Feb/Mar 2014. Veterans of course may already be seen at our clinics but this agreement will allow the Absentee Shawnee clinics to be reimbursed by the VA services, whereby many members access services at the VA in OKC. eligible services for our tribal veterans to begin in early Feb/Mar 2014. A pending selection for a new medical director is under review by the Governor's office, Shareholders Representatives, the ASTHA and Li-Si-Wi-Nwi Health, Inc., Boards. The Shareholders Representatives will meet and vote on this pending action. At the request of the Tribe the AG will negotiate and/or work on an offer of employment to the prospective Native American candidate.

Access to care in both the behavioral health and dental area's is improving by entering into additional service or employment agreements. Our Primary care will add some new providers after Christmas to both the Shawnee and Little Axe clinics to help with same day appointment requests and/or acute same day appointment access needs.

The new Diabetes Grant Coordinator, Mrs. Emily Key, is also on board now and making rapid gains in reinvigorating this effort with technical assistance from the I.H.S. area office's Endocrinologist, Dr. Briarasche.

#### Office of Environmental Health & Engineering (OEH&E)

The OEH&E Director attended the Indian Health Service Fall Meeting December 11&12, 2013. The agenda included Rural Development Funding, Final Reports and HITS Reports-Tracking Progress through GPS site locating home sites. Once the home sites are located we will report them in the IHS Housing Inventory Tracking System (HITS) system online.

OEH&E is completing two water well renovations that include new well houses that had been destroyed by the Tornadoes. OEH completed a water well chlorination for a member that was having issues with bad smells in the water system from non-use.

OEH met with the EPA on the Thunderbird Water System for sanitary survey that was completed. The EPA will provide a final report sometime in Jan 2014. The EPA did provide a preliminary finding report for deficiencies that need to be resolved. OEH is working on resolving these issues now before the final report is issued in Jan. Examples of deficiencies are: the overflow on water storage tank #1 does not terminate within 12 to 24" from the ground. Both standpipes need to be cleaned; standpipe #1 appears to have a leak at the base. The EPA did recommend that we provide a full time water operator for the AST water systems as we continue to expand.

I am finishing up on the Environmental Assessment for the Indian Community Development Block Grant (ICDBG) Tribal Youth Camp project at this time. The required Archeological Survey report has been completed on the 200 acre site. As soon as we complete the Environmental Assessment and post the findings, we will be able to start construction of the camp site, which is expected within the month of Jan 2014.

The L.A. Daycare Project-I met with the contractor and Lauri Brockman of Wasserstrom and Sons who is a commercial kitchen equipment supply company. We sat down and figured the sizes of all the required equipment for the kitchen. At the conclusion of the meeting it was determined the kitchen size needs to be enlarged to accommodate the equipment, storage

and allow for an eat-in dining area.

On Friday, December 13, 2013 I met with the contractor and Briana Ponkilla and went over the Daycare Kitchen layout and came up with a kitchen layout that will accommodate all the kitchen equipment, storage and eat-in requirements needed. I am scheduling a meeting with the Daycare Architect as soon as possible to make these kitchen corrections.

#### **Intergovernmental Relations & Planning**

Again, I would like to bring up the need for a full functioning Planning and Intergovernmental Relations Office. It is my intent to put this office into place in January. Currently I am receiving some resistance from some of the elected body and Finance. This office is strongly needed to conduct planning initiatives, data accumulation, liaison efforts with regulatory and legislative bodies. If we are to make progress for the future we have to take the right steps to do it. This is one of those. Let me reiterate this office will have 5 to 6 staff in it. The funding this year will come from 'carryover' from the clinic and not directly out of compact funds. Funds under Indian Health Service are under my direct oversight. We as a Self-Governance tribe are authorized under P.L. 93-638, as amended, which gives tribes the flexibility to utilize compact funds within their systems as the tribe deems appropriate. The planning function will assist the tribe and the health department. Next year (or if possible to get the Indirect Cost rate proposal modified this year) this function may be predominantly paid out of indirect cost.

Recentlylattended the Tribal Nations Leaders conference in Washington, D.C. and I along with many other Tribal leaders was interviewed by the National Congress of American Indians (NCAI) about my viewpoint on the mascots being used by professional teams. Of the many tribal leaders interviewed I was one of the individuals used by NCAI to illustrate the concerns of Tribes to our United States elected officials. Today our legal firm advised that there is a strong push by Obama, the congressional and senate majority leaders to take a position on the accurate portrayal of Native Americans on the use of team mascots. I believe that although my piece in this project was small it added to making a positive change that will be felt by our Indian children. I, and my Special Projects Coordinator, Lesa B. Shaw, while in Washington, D.C. met with Senator Coburn and Inhoffe's staffers; we also met with Congressman Lankford and with Congressman Cole's staffers; and Assistant Secretary Kevin Washburn on key issues facing our Tribe. It was a full and very productive visit.

In conclusion – I have 18 months to go and we are seeing some changes taking place but I need your help and support to continue these forward moving initiatives. Change takes time and I don't have that much left. While I am here I want to accomplish everything I can for you, for our children, young adults, adults and elders. I am calling upon you to help me move things forward – how can you do that? Support me through letters, cards, calls – telling other Executive Committee members this is what you want and please attend the Executive Committee meetings to be a part of this great challenge and opportunity!

## **Victim Advocacy**

Assist victims by offering educational classes that focus on the dynamics of domestic violence and sexual assault, stalking and dating/violence. Each victim is helped with emotional support and resources both from Tribal programs and local community programs.

## **Court Advocacy**

Assists survivors with domestic violence court related appearances as well as filing for emergency protective orders (EPO).

# **Housing and Utility Assistance**

Assists victims of domestic violence, sexual assault, stalking, and/or dating violence in emergency situations. This assistance may allow for a victim to either receive housing or utility assistance.

#### Referral Assistance

Assists with providing community resources to those who are in need of additional services outside the scope of the Absentee Shawnee Tribe's Domestic Violence Program.

# **Sexual Assault Advocacy**

The AST DV Sexual Assault Program is on-call 24 hours per day to provide emotional support, advocacy and crisis counseling to sexual assault survivors at hospitals, police stations and throughout the legal system. The program also serves as a resource center to the community by offering educational information and referrals.

## **Shelter Placement Assistance**

The Absentee Shawnee Tribe's Domestic Violence Program works with other shelters within Oklahoma in order to help victims obtain safe housing. Emergency transportation for the victim and children may also be available

# **Community Outreach**

The Absentee Shawnee Tribe's Domestic Violence Program offers educational trainings, informational displays, and community events in order to provide more awareness to both Tribal and non-Tribal communities.

The information being provided is to help families understand what programs are offered through the Absentee

Shawnee Housing Authority and how to apply.

Our programs target low income Native American families who need housing assistance. The programs currently being provided are Rental, Lease to Own and Down Payment Assistance

#### Application Process

Our process begins with the completion of our housing application. When completing the application be sure and answer all the questions that pertain to you and sign all attached forms. If you should have any questions regarding the application; call or come by our office and ask our staff in the Programs & Admissions Department and they would be glad to assist you.

The application will also require documents to be attached in order

- Photo I.D. CDIB Card
- Social Security Card
- Birth Certificate
- Marriage License/Divorce Decree/Custody Decree (if applicable Declaration of Section 214 (form is included with application)

Each household member must provide a birth certificate, social security card and CDIB card (if enrolled in a federally recognized tribe). The Housing Authority will conduct a criminal background check and credit check on all adult household members over the age of 18. A home visit is the final step in completing your

A letter will be mailed out once your application has been A letter will be mailed out once your application has been approved notifying you of the date your name was placed on the waiting list. It is very important to stay in contact and notify the Housing Authority anytime changes occur in income, household composition, or contact information.

In the event that your name is next in being offered a home; you will be notified by letter or phone.

Annual Updates required to remain on the waiting list.

The application is the same as the rental; accept the income requirements are different. Be sure and specify when completing your application, that you are applying for the Lease to Own Program. 



# SAFETY TIPS FROM...

- √ Never leave children alone in or around cars; not even for a minute.
- √ Put something you'll need like your cell phone, handbag, employee ID or brief case, etc., on the floor board in the back seat.
- √ Get in the habit of always opening the back door of your vehicle every time you reach your destination to make sure no child has been left behind. This will soon become a habit. We call this the "Look Before You Lock" campaign.
- √ Keep a large stuffed animal in the child's car seat when it's not occupied. When the child is placed in the seat, put the stuffed animal in the front passenger seat. It's a visual reminder that anytime the stuffed animal is up front you know the child is in the back seat in a child safety seat.
- √ Make arrangements with your child's day care center or babysitter that you will always call if your child will not be there on a particular day as scheduled.
- √ Keep vehicles locked at all times; even in the garage or driveway and always set your parking brake.
- √ Keys and/or remote openers should never be left within reach of children.
- √ Make sure all child passengers have left the vehicle after it is parked.
- √ When a child is missing, check vehicles and car trunks immediately.
- √ If you see a child alone in a vehicle, get involved. If they are hot or seem sick, get them out as quickly as possible. Call 911 or your local emergency number immediately.
- √ Be especially careful about keeping children safe in and around cars during busy times, schedule changes and periods of crisis or holidays.
- √ Use drive-thru services when available. (restaurants, banks, pharmacies, dry cleaners, etc.)
- $\sqrt{}$  Use your debit or credit card to pay for gas at the pump.

# Education Department

The following are current programs administered by the Absentee Shawnee Tribe Education Department:

These are brief descriptions of current programs. Program guidelines are available in hard copy for at the Education Department office or for download at www.astribe.com.

- <u>Academic (K-12) Program</u>: assists with academic related expenses, and a portion of funds can be used for school-related athletic program expenses. Program has a maximum funding limit for the academic year.
- Zahn Program: established from a trust fund, program can help with some graduation expenses, and awards two (2) incentives: one for GED recipients and one for High School graduates. Program has a maximum amount of funding for graduation expenses.
- <u>Job Training Adult Education Program</u>: funds for vocational training at accredited vocational institutions. Program has a maximum funding limit for the calendar year or per program.
- Higher Education: <u>Education Incentive Award Program</u>: funds for undergraduate degrees, one associates or bachelors degree, at any accredited college or university. Funding levels are determined based upon grade point average and full-time or part-time status.
- Graduate Scholarship Program: funds for one master's degree or one doctoral degree, and can fund for one graduate admissions test. This program has funding levels based upon full-time and part-time status.

# ASTribe Indian Child Welfare Department FOSTER CARE

This article appears in the Daily Times in Farmington, New Mexico. And even though this talks about the foster care program and tribal children in foster care, this article can speak on behalf of what the Absentee Shawnee Tribe Foster Care and other tribes are going thru. Finding foster homes is a necessary to not only protect AST children but to also maintain their cultural identity, heritage and traditions. The Absentee is a small tribe and we should be able to work as ONE TRIBE to care for the AST children. If you have any questions, contact the ICW department at (405)275-4030.

"Only two foster homes in San Juan County belong to American Indian families, but more than half of the 85 children in foster care now are American Indian. That means about 40 American Indian youths in the local foster system are living with non-native families. The Children, Youth and Families Department, charged with placing children in alternate homes if their own families are deemed unsafe for reasons of abuse or neglect, is having a hard time finding enough native families for the number of native children in the system.

The department does everything it can to match a child with a family of a similar background. That doesn't work when fewer homes than children are in the system, which means native children more often than not end up in non-native families. This is contrary to federal policy, which directs the department to make every effort to place children of American Indian descent in homes that nourish their cultural identity. But without more native families stepping up to offer a home for children, there is little the department can do to remedy this situation.

The Indian Child Welfare Act provides four placement options, which the department must pursue in descending order every time it places a native child. The first option is to place American Indian children with a relative who can provide a safe environment and who eventually attains a foster care license. The second option is for a child to be placed in a family from the same American Indian tribe. The third is for the child to be placed with a American Indian family not of the same tribe. The final option, and the one the CYFD most often uses, is matching native children with non-native families that simply have a foster care license.

This is a loss for children and for potential foster families. It's also a loss when it comes to efforts to revitalize native traditions and teach them to the children. We encourage all native families with the resources that can allow children a home to contact the Children, Youth and Families Department. Fostering a child is one of the most rewarding things a family can do."

In the state of Oklahoma alone, there are almost 3000 Native American children in the foster care program with a majority of these children placed in non-native placements. Now imagine if your son, daughter, grand children were placed in another home that didn't teach or understand the Absentee Shawnee traditions. What would happen to their identity, their sense of being a AST, their sense of belonging and being proud of being a Absentee Shawnee?

The AST ICW dept are in need to foster homes. Emergency homes, temporary homes, it doesn't matter. We have made it a goal to get certify at least 5 homes to be foster homes for the AST. With obtaining more every year from this point on. It takes ONE TRIBE to care for ONE CHILD. As the great Tecumseh said, "A SINGLE TWIG BREAKS BUT A BUNDLE OF TWIGS IS STRONG."

Are you at risk for diabetes, have diabetes or know someone who does? Type 2 diabetes is the most common type of diabetes and affects millions of Native Americans. Many people are unaware that they have diabetes or pre-diabetes. Native Americans are twice as likely to develop

Type 2 diabetes than others. Some common signs and symptoms include:

- Frequent infections
- Blurred vision
- Cuts/bruises that are slow to heal
- Tingling/numbness in the hands/feet
- Recurring skin, gum, or bladder infections

Often people with type 2 diabetes have no symptoms.

Some ways to prevent and manage diabetes is through healthy lifestyle behaviors. One question that many people with diabetes or pre-diabetes often ask is "What can I eat?". The American Diabetes Association states that you do not have to be deprived or restricted. The key factors are learning what are the "superfoods", how much of it you can have and how often. Getting into the habit of eating a healthy diet helps you manage diabetes and prevent complications caused by diabetes.

The following foods are listed on the American Diabetes Association web site as" superfoods". Try to incorporate as many of these foods into your daily meal plan to enhance the nutrient content of your meals.

The foods listed have a low glycemic index (causes slower rise in blood glucose after eating) and provide key nutrients that are lacking in the typical western diet such as:

- calcium
- potassium
- magnesium
- vitamins A, C, and E. fiber

Beans,dark green leafy vegetables, citrus fruit, sweet potatoes, berries, tomatoes, fish high in Omega-3 fatty acids, whole grains, nuts, fat-free milk and yogurt. 
